THE VILLAGE AUTHORITIES LAWS, 1931 TO (No. 2) 1937.SPECIAL AUTHORIZATION UNDER SECTION 13A (1) AND 13A (3).

I, S. W. C. IRRIGATION DIVISION OF "SKLEDROS" PRODHROMOS.*Rules.*

These rules may be cited as the Irrigation Division of "Skledros" Prodhromos (Amendment) Rules, 1949, and shall be read as one with the Irrigation Division of "Skledros" Prodhromos Rules, 1938 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of "Skledros" Prodhromos Rules, 1938 and 1949.
