- 1. This Order may be cited as the Plants (Prevention of Diseases) Amendment Order, 1950, and shall be read as one with the Order No. 1421 published under No. 367 in the Gazette of the 1st May, 1931, the Order No. 1426 published under No. 607 in the Gazette of the 31st July, 1931, and the Order No. 1643 published under No. 711 in the Gazette of the 28th June, 1935 (all of which said Orders are hereinafter together referred to as "the principal Orders"), and the principal Orders and this Order may together be cited as the Plants (Prevention of Diseases) Orders, 1931 to 1950.
- 2. Clause 7 of the principal Orders is hereby amended by the insertion therein, immediately after the words "except cotton seed" (line 5) of the words "and sunflower seed".

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) ACT, 1945.

ORDER MADE BY THE GOVERNOR.

In exercise of the powers vested in me by the Supplies and Services (Transitional Powers) Act, 1945, as extended to the Colony by the Supplies and Services (Transitional Powers) (Colonies, etc.) Order in Council, 1946. I, the Governor, do hereby order as follows:-

- 1. These regulations may be cited as the Defence (Exportation of Goods) (Amendment) Regulations, 1950, and shall be read as one with the Defence (Exportation of Goods) Regulations, 1943 and 1948 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence (Exportation of Goods) Regulations, 1943 to 1950.
- 2. Regulation 2 (1) of the principal Regulations shall be varied to read
- and to have effect as follows:—
 "2.—(1) Subject to the provisions of regulation 3 of these regulations the export from the Colony of all goods is prohibited save under the authority of a licence granted by the Controller of Supplies and subject to such terms and conditions (including the price at which such goods shall be sold abroad) as may be specified in such licence."

3. Regulation 3 of the principal Regulations shall be varied to read and to have effect as follows:-

"3. Nothing in regulation 2 of these regulations contained shall

apply to-

(a) any goods being bona fide baggage of a passenger, the property of and accompanied by, such passenger, and proved to the satisfaction of the Comptroller that they are for the personal use of such passenger.

For the purposes of this paragraph the expression 'baggage' has the same meaning as in item 10 of the Second Schedule to the Customs Laws, 1936 to (No. 3) 1948 (as set out in Law 7 15 of 1948
