(c) in any way interfere with the water or the works, without the licence in writing of the Committee previously obtained and subject to such terms and conditions as the Committee may impose, and if any person to whom such licence has been granted acts in contravention of, or fails or neglects to observe, the terms and conditions thereof, he shall be guilty of an offence against this rule.

14. Every proprietor through whose lands there pass any channels shall at all times keep such part of such channels as may pass through his lands, clean and free from all obstructions whatsoever and if he fails to do so the Committee may cause any obstructions to be removed from such part of the channel and the cost thereof shall be paid by the proprietor concerned in addition to the rate payable by such proprietor under rule 5 without prejudice to any other liability of such person for the breach of this rule.

15. If there are two or more proprietors interested in any channel and they are unable to agree between themselves for the repair of any such channel and the clearing of the same of obstructions, the Committee shall cause such channel to be repaired and cleared of obstructions and the cost therefor shall be paid by the proprietors concerned in such proportion as the Committee may direct, in addition to the rate payable by every such proprietor under rule 5.

16. The Committee shall distribute the water from time to time to every proprietor in accordance with the interest of each proprietor as recorded in the list and in accordance with the usage heretofore observed with regard to the turn of irrigation and distribution of such water.

17. The Committee may with the consent of the Commissioner enter into any agreement or

arrangement with the Committee of any other irrigation association or of any irrigation division formed under the provisions of the Law or of the Irrigation Divisions (Villages) Laws, 1938 to 1949, as the case may be, with regard to any dams or channels which are shared in common between the Irrigation Association and such other Irrigation Association or Irrigation Divisions, the maintenance thereof and the proportion of any contribution for any expenses incurred in connection therewith to be paid by the Irrigation Association.

18.—(1) Upon an application to the Commissioner signed by not less than two-thirds of the proprietors mentioned in the list requesting that the Irrigation Association be dissolved, the Commissioner shall, subject to the provisions of section 4 of the Law, call a meeting of the proprietors for the purpose of determining whether the Irrigation Association should be dissolved.

(2) Every meeting so convened shall be held in the presence of the Commissioner at the time

1 place appointed.
(3) No business shall be transacted at any such meeting and no decision shall be taken thereat, unless more than one-half of the aggregate number of the proprietors are present in person or are represented by a proxy properly appointed by an instrument signed in the presence of and certified by a mukhtar.

(4) If, subject to the provisions of sub-paragraph (3) above, the majority of the proprietors or the authorized proxies thereof who are present decide that the Irrigation Association should

be dissolved, the Irrigation Association shall be so dissolved accordingly:

Provided that a proxy holding authority from more than one person shall be entitled to

vote in respect of every proprietor from whom he holds authority:

Provided also that all charges due and unpaid on the date of dissolution shall be levied and paid as if the Irrigation Association had not been dissolved.

(5) Any money in the hands of the Committee or the treasurer at the time of the dissolution of the Irrigation Association and any money recovered at any time thereafter on account of the rates due and unpaid at the time of such dissolution, shall be paid to the Commissioner, and shall be passed in the books of the Commissioner to the credit of the village of Sisklipos and shall be utilized by the Commissioner for such purpose of public utility in the village of Sisklipos as may be approved by him.

## No. 81. THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

The following Rules made by the Village Health Commission of Kornos, in the District of Larnaca, and approved by the Commissioner, are published in the Gazette.
Rules made by the Village Health Commission of Kornos

UNDER SECTION 9. In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Kornos hereby

nake the following Rules:—

1. These rules may be cited as the Village Health (Kornos) (Amendment) Rules, 1950, and shall be read as one with the Village Health (Kornos) Rules, 1938 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Village Health (Kornos) Rules, 1938 and 1950.

Part I of the Schedule to the principal Rules is hereby amended by the insertion therein of the following rules immediately after rule 3:—

CHAPTER 2.—Meat Market. 38. The Village Health Commission may from time to time by public notification appoint any premises or place within the area of the village to be the meat market.

39. The management and control of the meat market are hereby vested in the person

appointed from time to time by the Village Health Commission to be the Inspector of such market (hereinafter in this chapter of these rules referred to as "the Inspector") subject to the instructions which he may from time to time receive from the Village Health Commission.

40. The meat market shall be opened and shall be kept open daily from sunrise to sunset except on Sundays when it shall be closed at 2 p.m.: Provided that the said market may be opened or kept open with the permission of the Inspector at such other time and for such other period as may be required.

41. No person shall sell or expose for sale within the area of the village any

fresh meat, except at the meat market.

42. No person shall bring or cause to be brought into the meat market: (a) Any skin, whether fresh or dry of any animals, or

(b) Any pork, whether fresh or dry, or (c) Any preparation made of the flesh of any swine.

43. All fresh meat exposed for sale in the meat market shall be open at all times to inspection by the Village Health Commission, the Medical Officer and the Inspector.

44. All fresh meat exposed for sale in the meat market, which in the opinion of the Medical Officer or the Village Health Commission is unfit for human

consumption may be seized and destroyed by the Inspector.

45. The shops, stalls, places and space situated in the meat market may be let on hire by the Village Health Commission for such period and on such terms and conditions as the Village Health Commission may from time to time determine: Provided there are other shops, stalls or places therein for the sale of fresh meat by persons other than lessees.

46.—(1) The following fees shall be paid by every person exposing for sale any

fresh meat in the meat market, that is to say :-

(2) The fees in paragraph (1) of this rule prescribed shall not be payable by any person exposing for sale any fresh meat in the meat market who is a monthly or yearly lessee of any shop, stall or place in the market under rule 45 of these rules.

47. Every fee payable under this chapter of these rules shall be paid to the

Inspector.

48. In this chapter of these rules the term "fresh meat" means the fresh meat of any bullock, camel, cow, goat, kid, lamb, ox or sheep.

## CHAPTER 3.—Pork Market.

49. The Village Health Commission may from time to time by public notification appoint any premises or place within the area of the village to be the pork market.

50. No person shall sell or expose for sale within the area of the village any carcass of swine or any pork, except at the pork market.

51. The management and control of the pork market are hereby vested in the person appointed from time to time by the Village Health Commission to be the Inspector of the pork market (hereinafter in this chapter of these rules referred to as "the Inspector"), subject to the instructions which he may from time to time receive from the Village Health Commission.

52. All carcasses of swine and all fresh pork exposed for sale in the pork market shall be open at all times to inspection by the Village Health Commission, the Medical

Officer and the Inspector.

53. All carcasses of swine and all fresh pork exposed for sale in the pork market, which in the opinion of the Medical Officer or the Village Health Commission are unfit for human consumption may be seized and destroyed by the Inspector.

54.—(1) The following fee shall be paid by the owner of or the persons exposing for sale any carcass of swine or fresh pork in the pork market, that is to say, for every carcass of swine or part thereof or portion of fresh pork, 8 piastres.

(2) Every such fee shall be paid to the Inspector.

## CHAPTER 4.—Market of Food-stuffs.

55. The Village Health Commission may from time to time appoint any premises or place within the area of the village to be the market of food-stuffs.

- 56. The management and control of the market of food-stuffs are hereby vested in the person appointed from time to time by the Village Health Commission to be the Inspector of the market of food-stuffs (hereinafter in this chapter of these rules referred to as "the Inspector") subject to the instructions which he may from time to time receive from the Village Health Commission.
- 57.—(1) The following fees shall be paid by every person exposing for sale any food-stuffs in the market of food-stuffs, that is to say:—
  - (a) For every load of food-stuffs exceeding 100 okes (b) For every load of food-stuffs under 100 okes (c) For every motor lorry loaded with food-stuffs (d) For every part of a lorry load of food-stuffs (2) The fees in this rule prescribed shall be paid to the Inspector,

58. In this chapter of these rules the term "food-stuffs" means any marketable commodities, articles, things or liquids used for human consumption but does not include any perishable goods or fresh meat or fresh pork.

CHAPTER 5.—Special provisions relating to Markets.

59. Every person selling or exposing for sale fresh meat in the meat market or fresh pork in the pork market shall:

(1) To the satisfaction of the Village Health Commission, the Medical Officer and the Inspector of such markets respectively:—

. (a) provide himself with suitable knives and with proper and correct weights, scales, balances or other apparatus, and

(b) be clad, in addition to the ordinary wearing apparel, with a clean white apron, extending from the neck to below the knee, and

- (c) keep all shops, stalls and places rented or occupied or used by him in the said markets thoroughly clean, ventilated and in proper sanitary condition,
- (d) keep all tables, benches, counters, hooks, supports or other furniture in the shops, stalls and places rented or occupied or used by him in the said markets in a thoroughly clean condition, and

(e) keep all weights, scales, balances or other apparatus used by him in a thoroughly clean condition, and

(f) keep all fresh meat or fresh pork flyproof and insectproof, and

-(a) afford free access to the shops, stalls and places rented or occupied by him in the said markets to the Village Health Commission, the Medical Officer and the Inspectors of the said markets respectively, and (b) render to the Village Health Commission, the Medical Officer and the

Inspectors of the said markets respectively, such assistance and information

- as they may reasonably require, and (c) obtain from the Medical Officer in every year and have in his possession a certificate to the effect that his state of health and physical fitness are such as not to admit of the possible infection of any such fresh meat or fresh
- (d) produce such certificate as aforesaid at all times on request to the Inspectors of the said markets respectively.

60. No person shall sleep in any shop, stall, place or space in the meat market, pork market or market of food-stuffs or shall cause or allow or suffer any such shop, stall, place or space to be used as sleeping quarters.

THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF POLITIKO UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Politiko hereby make the following rules:-

- 1. These rules may be cited as the Village Health (Politiko) Rules. 1949, and shall come into operation on their publication in the Gazette.
- 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule. the Village Health (Karavostasi) Rules, 1938, published in the Gazette of 4th March, 1938, shall-
  - (a) be deemed to be rules made by the Village Health Commission of Politiko and to be incorporated herein, and
  - (b) apply to the village of Politiko.
- (2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Karavostasi) Rules, 1938.
