THE EMERGENCY POWERS (CYPRUS DEFENCE) (FINANCE)
REGULATIONS, 1940 TO 1949.

NOTICE.

It is hereby notified for general information that His Excellency the Governor has been pleased to appoint the Financial Secretary with effect from the 1st of January, 1951, to be "Exchange Officer" generally for the purposes of the Emergency Powers (Cyprus Defence) (Finance) Regulations, 1940 to 1949, and in particular:

(a) to act on behalf of the Governor in respect of all or any of the following matters, that is to say:—

- (i) in the event of an order being made under regulation 3, to grant permissions thereunder and to be the person to whom returns should be made thereunder;
- (ii) to grant permissions under regulation 5 (1);
- (iii) to grant certificates under regulations 5 (2) and 5 (5);
- (iv) to be the person designated for the purposes of regulations 6 and 7;
- (v) to give directions under regulation 11;

(b) to act as an appropriate officer for the purposes of paragraphs (3) and (5) of regulation 5.

2. The arrangements made by Notification No. 30 published in Supplement No. 3 to the *Gazette* of the 27th January, 1949, are cancelled, and the appointment of the Controller of Supplies as "Exchange Officer" is terminated as from the 1st day of January, 1951.

No. 12. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

Whereas by Notification dated 28th day of June, 1947, and published under Notification No. 186 in Supplement No. 3 to the *Gazette* of the 3rd July, 1947, the Governor declared under sections 2 and 3 of the Land Acquisition Laws, 1899 to 1947 (hereinafter referred to as "the Laws") the erection, within the district of Larnaca, of a power station, offices, workmen's quarters and any other erections or structures as are from time to time considered to be necessary in connection with a scheme for the generation and supply of electricity in Cyprus (hereinafter referred to as "the scheme") to be an undertaking of public utility;

And whereas it has been represented to me that it is desirable in the public interest and for the purposes of the scheme to erect within the district of Limassol another power station and such other erections or structures as may from time to time be considered necessary in connection with the scheme:

Now, therefore, in exercise of the powers vested in me by sections 2, 3 and 4 of the Laws, I, the Governor, do hereby declare the erection, within the district of Limassol, of a power station and such other erections or structures as are from time to time considered to be necessary for the scheme to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Chief Engineer, Central Electrification Scheme, the supervision and effectuation of the said undertaking.
