THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1950.

ORDER IN COUNCIL No. 2468

MADE UNDER SECTION 116 (a) (i).

*Authority to the Council of the Municipal Corporation of Paphos to contract
a loan.*

In exercise of the powers vested in me by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1950, I, the Governor with the advice of the Executive Council, do hereby order as follows :—

1. The Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Paphos (hereinafter referred to as "the Municipal Corporation") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") a sum not exceeding twenty thousand pounds (£20,000) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say :—

- (a) the sum borrowed shall be utilized for the improvement of the distribution system of the water supply in Ktima ;
- (b) tenders shall be invited for the supply of all items, materials, etc., and the detailed specification of the items of equipment or materials to be ordered shall be agreed to by the Water Engineer ;
- (c) tenders shall be invited for the execution of the works connected with the scheme referred to in (a) above except where the Water Engineer has agreed that such work can advantageously be carried out by the employees of the Municipal Corporation, in which case all technical details of the work and the manner in which it will be carried out shall be subject to the Water Engineer's approval ;
- (d) no tender shall be accepted except with the prior written approval of the Water Engineer who shall at all times have the right to give to the successful tenderer through the Municipal Engineer such directions as the Water Engineer may deem fit for the purpose of ensuring proper execution of the work in accordance with the terms of a contract to be entered into in that connection ;
- (e) withdrawals of loan money shall be made against the certificate of the Water Engineer and the Municipal Engineer stating the progress of work and/or the cost of the materials purchased and delivered ;

- (f) the sum borrowed shall, subject to the second proviso to paragraph (g) of this clause, be repayable by the Municipal Corporation to the Lender in seventeen equal annual instalments (comprising sinking fund and interest), the first instalment to become due and payable one year after the final withdrawal has been made by the Municipal Corporation on completion of the work or the 30th June, 1952, whichever date is the earlier and the subsequent instalments being payable on the corresponding date in each year following ;
- (g) interest accrued on the amounts withdrawn shall be paid yearly from the date of withdrawal until the final withdrawal has been made or until the 30th June, 1952, whichever date is the earlier :
- Provided that any interest that may be outstanding on any amount already withdrawn on the date of the last withdrawal or on the 30th June, 1952, whichever date is the earlier, shall be paid on that date :
- Provided further that if any withdrawal is made after the 30th June, 1952, the interest payable on the next annual instalment shall be adjusted accordingly ;
- (h) the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in its annual estimates as a charge on its revenues the sums payable as aforesaid in the year to which such estimates relate.

2. For the purpose of securing the repayment of the sum under the loan, the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.
