

No. 127. THE LAND ACQUISITION LAWS, 1899 TO 1947.**NOTIFICATION UNDER SECTIONS 2, 3 AND 4.**

Whereas there is a scheme for the improvement of the water supply of the Municipal Corporation of Limassol ;

And whereas it has been represented to me that for the purposes of the aforesaid scheme it is desirable in the public interest that the Municipal Corporation of Limassol should acquire certain land with trees situated outside the municipal limits at the locality Halospida in the village of Ayia Phyla, and certain springs and water rights known as " Mavromata " and " Kephalovryso " situated outside the municipal limits in the villages of Khalassa and Pano Kividhes respectively, and that, for this purpose, it is desirable that it should be recognized as a public body for the purposes of the Land Acquisition Laws, 1899 to 1947 :

Now, therefore, in exercise of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1947, I, the Governor, do hereby declare—

- (a) the scheme for the improvement of the water supply of the Municipal Corporation of Limassol and the acquisition of the aforementioned lands, trees, springs and water rights to be an undertaking of public utility for the purposes of the aforesaid Laws ;
- (b) the Municipal Corporation of Limassol to be recognized as a public body for the purposes of the aforesaid Laws.

And I do hereby authorize the carrying out of the said undertaking and entrust the supervision and effectuation of such undertaking to the Municipal Commission of Limassol.

No. 128. THE LAND ACQUISITION LAWS, 1899 TO 1947.**NOTICE UNDER SECTION 5.**

With reference to the Notification published under No. 127 in Supplement No. 3 to the *Gazette* of the 14th March, 1951, notice is hereby given that the following land and trees are required by the Municipal Corporation of Limassol for an undertaking of public utility :—

The field, 12 donums in extent, with all the trees standing thereon, being marked as plot 49 on the Government Survey Plan No. LIV.50, more particularly defined as the area coloured red on the plan marked " Limassol Water Supply " dated 10th March, 1951, deposited with the Commissioner of Limassol.

Any person claiming to have any right or interest in the said land or trees is required within six weeks from the date of the publication of this notice in the *Gazette* to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

The Municipal Corporation is willing to treat for the acquisition of the said land and trees.

A plan showing the land described above is available for inspection at my office at Limassol.
