### THE WIRELESS TELEGRAPHY LAWS, 1913 TO 1948.

ORDER MADE BY THE GOVERNOR UNDER SECTIONS 3 AND 7.

In exercise of the powers vested in me by sections 3 and 7 of the Wireless Telegraphy Laws, 1913 to 1948, I, the Governor, do hereby order as follows :—

1. This Order may be cited as the Wireless Telegraphy (Amendment) Order, 1951, and shall be read as one with the Wireless Telegraphy Order, 1949 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Wireless Telegraphy Orders, 1949 and 1951.

2. Condition 12 of the Amateur's Licence as set out in the Third Schedule to the principal Order is hereby amended by the deletion therefrom of the words :

"The station shall be used in such manner as not to cause interference with other stations outside the authorized bands" (lines 1 and 2) and the substitution therefor of the following words :

"The station shall be used in such a manner as not to cause avoidable interference with the working of other stations (whatever the frequency)".

### No. 138. THE JUVENILE OFFENDERS LAW, 1946.

REGULATIONS MADE UNDER SECTION 23.

In exercise of the powers vested in me by section 23 of the Juvenile Offenders Law, 1946, I, the Governor, with the advice of the Executive Council, do hereby make the following regulations :—

1. These regulations may be cited as the Juvenile Offenders (Amendment) Regulations, 1951, and shall be read as one with the Juvenile Offenders Regulations, 1946 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Juvenile Offenders Regulations, 1946 and 1951.

2. Paragraph (d) of regulation 37 of the principal Regulations is hereby amended by the deletion therefrom of the words "two piastres" and the substitution therefor of the words "three piastres".

This Order may be cited as the Defence (Heaters Control) (Amendment) Order, 1951, and shall be read as one with the Defence (Heaters Control) Orders, 1944 to (No. 2) 1945 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Defence (Heaters Control) Orders, 1944 to 1951.

2. Clause 2 of the principal Order is hereby amended by the deletion therefrom of the definition "Fuel and Charcoal Controller" and the substitution therefor of the following definition :—

" ' Fuel and Charcoal Controller ' means the Conservator of Forests or any other person whom I may appoint to be the Fuel and Charcoal Controller by notice in the *Gazette*."
