"property" has the same meaning as that assigned to it in section 9 of the Law ;

"securities" means annuities, stock, shares, bonds, coupons, debentures or debenture stock registered or inscribed in any register, branch register or other book kept in the Colony or transferable by delivery of any document situate in the Colony ;

"Vesting Order" has the same meaning as that assigned to it in clause 4 of the Trading with the Enemy (Custodian) Orders, 1940 to 1946.

THE ELEMENTARY EDUCATION LAWS, 1933 TO 1950.

REGULATIONS MADE UNDER SECTION 5.

In exercise of the powers vested in me by section 5 of the Elementary Education Laws, 1933 to 1950, I, the Governor, do hereby make the following regulations :—

1. These regulations may be cited as the Elementary Education (Books in Greek-Orthodox Schools) (Amendment) Regulations, 1951, and shall be read as one with the Elementary Education (Books in Greek-Orthodox Schools) Regulations, 1937 and 1946 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Elementary Education (Books in Greek-Orthodox Schools) Regulations, 1937 to 1951.

THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 TO 1949
 (Section 31)

AND

THE LAND ACQUISITION LAWS, 1899 TO 1947.

Whereas on certain land at Kato Lefkara village belonging to Panayotou Nicola Anjuli, of Kato Lefkara, a channel has been constructed for the conveyance of water by the Irrigation Division of Kato Lefkara ;

And whereas it has been represented to me that such land is required for the irrigation works of the said Irrigation Division ;

And whereas there is a hindrance to the acquisition of such land ;

Now, therefore, in exercise of the powers vested in me by section 31 of the Irrigation Divisions (Villages) Laws, 1938 to 1949, I, the Governor, do hereby declare that such land is land needed for a public purpose and do hereby order that proceedings be taken for acquiring the same and for determining the compensation to be paid to any parties interested in accordance with the Land Acquisition Laws, 1899 to 1947, and do hereby entrust to the Commissioner of Larnaca the supervision and effectuation of the said acquisition under the respective provisions of the Land Acquisition Laws, 1899 to 1947.
