**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE REGULATION 61

In exercise of the powers vested in me by virtue of my appointment by the Governor as a Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force in consequence of the Supplies and Services (Continuance) Order, 1950, I hereby order as follows:—

1. This Order may be cited as the Supplies and Services (Zivania Control) (Amendment) Order, 1951, and shall be read as one with the Supplies and Services (Zivania Control) Orders, 1949 and 1950 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Supplies and Services (Zivania Control) Orders, 1949 to 1951.

2. Clause 6 of the principal Order is hereby amended by the deletion therefrom of the words "from his town or village except for the purpose of its delivery to an authorized purchaser". (lines 3 and 4) and the substitution therefor of the words "from any town or village to any other place in the Colony".

**THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND
CONTROL) LAW, 1948.**

NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, 1948, I hereby direct that during the period between the 16th April and the 31st May, 1951, flocks within the area of Yeri, Latcha and Eylenja villages shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure:

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.
