

No. 196. THE ANTIQUITIES LAWS, 1935 AND 1945—(Section 17 (2))

AND
THE LAND ACQUISITION LAWS, 1899 TO 1947.A. B. WRIGHT,
Governor.

Whereas excavations have been and are being carried out by the Kouklia Archaeological Expedition in or upon a certain plot of land situated in the village of Kouklia, in the District of Paphos ;

And whereas as a result of these excavations the remains of ancient structures were uncovered ;

And whereas I, the Governor, with a view to preserving these remains am satisfied that part of the plot in question should be compulsorily acquired :

Now, therefore, in exercise of the powers vested in me by section 17 (2) of the Antiquities Laws, 1935 and 1945, I, the Governor, do hereby direct that the plot described in the Schedule hereto be acquired on payment of such amount by way of compensation as may be agreed upon between the Commissioner of Paphos and the proprietors thereof and that in default of agreement within one month from the date hereof the amount of compensation be determined in accordance with the provisions of the Land Acquisition Laws, 1899 to 1947.
