## NOTICE UNDER SECTION 5.

With reference to the Notification published under No. 45 in Supplement No. 3 to the *Gazette* No. 3542 of 7th February, 1951, notice is hereby given that the following are required by the Governor for the undertaking of public utility mentioned therein, that is to say, the establishment of a military cantonment.

### Area " A " : Dhekelia.

(i) All that privately-owned land with the immovable property standing thereon, and the privately-owned immovable property on Crown land and in Minor State Forest situated in the village of PYLA, in

3. The Governor is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office in Larnaca.

Note.—The general boundary of Area "A" has been demarcated by cairns marked W.D. and has been pointed out to the village authorities of Pyla, Xylotymbou and Ormidhia.
