THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)  
LAWS, 1950.

ORDER UNDER SECTION 4 (b).

In exercise of the powers vested in me by section 4 (b) of the Villages (Administration and Improvement) Laws, 1950, I, the Governor, do, by this Order, declare that from and after the 1st day of July, 1951, the areas "A", "B" and "C" described in the First Schedule hereto be added to the improvement area of Troodos, the whole of which improvement area will thus be as described in the Second Schedule hereto.

FIRST SCHEDULE.

The areas lying within the following boundaries, that is to say :—  
*Area "A".*

The boundary commences at the boundary stone No. S.A.2, situated on the south side of the road about 200 yards west of the Government hut No. 1 and proceeds north-westwards in a straight line to the boundary stone No. S.A.3A, situated near the Government triangulation point No. B/4, locality "Mouyies"; thence north-eastwards in a straight line to the boundary stone No. S.A.4A, situated near the Government triangulation point No. 932/4, locality "Laonin-tou-Evretou"; thence north-westwards in a straight line to the boundary stone No. S.A.5A, situated near the Government triangulation point No. 930/4, locality "Palaea Khora"; thence north-eastwards in a straight line to the boundary stone No. S.A.6A, situated near the Government triangulation point No. 929/4, locality "Khionistra"; thence north-eastwards in a straight line to the boundary stone No. S.A.6B, situated on the north side of the road leading from Troodos to the village of Prodhromos; thence south-eastwards along the said road to a point where it joins a track, locality "Xerolimni"; thence along the said track to the boundary stone No. S.A.6C; thence north-eastwards in a straight line to the boundary stone No. S.A.6D, situated near the Government triangulation point No. 1929/4, locality "Dhistraton Amiandou"; thence south-eastwards in a straight line to the boundary stone S.A.7, situated at the junction of a stream with the stream from "Kannoures" spring, and on the boundary of the Districts of Nicosia and Limassol; thence south-westwards up the valley of the said stream to the boundary stone No. S.A.6, situated on a footpath from Troodos to Mount Olympus, about 50 yards south-east of the Government triangulation point No. 936/4; thence south-westwards in a straight line to the boundary stone No. S.A.5, situated in the bed of a stream about 170 yards south-west of the Government triangulation point No. 936/4; thence south-westwards in a straight line to the boundary stone No. S.A.4, situated about 70 yards north-east of the Government triangulation point No. D/4; thence south-westwards in a straight line to the boundary stone No. S.A.3, situated about 80 yards west of the Government triangulation point No. C/4, locality "Mouyies"; thence southwards in a straight line to the point of commencement, all which boundary of the said area is shown edged red on the Government Survey Plan Serial No. 1492.

*Area " B ".*

The boundary commences at the boundary stone No. S.A.8, situated 13 yards north-west of the Government triangulation point No. 939/4 and on the boundary of the Districts of Nicosia and Limassol and proceeds north-eastwards and eastwards along the said District boundary to the point where it is cut by the straight line from the Government triangulation point No. 1832/4 to the Government 3rd order point " East Shoulder ", locality " Livadhin-tou-Pasha "; thence southwards in a straight line to last mentioned point; thence south-westwards in a straight line to the mile post No. 48 on the main road from Nicosia to Troodos, locality " Almirolivadhon "; thence south-westwards in a straight line to the Government triangulation point No. 941/4, locality " Ayios Mamas "; thence south-westwards in a straight line to the boundary stone No. W.D.32, situated about 20 yards west of the Government triangulation point No. K/4, locality " Roudhia "; thence north-eastwards in a straight line to the boundary stone No. S.A.11, situated at the junction of the stream " Loumata " with another stream; thence northwards up the last mentioned stream to the junction of the main road from Nicosia to Troodos with a track, locality " Kremmos "; thence north-eastwards along the said track to the boundary stone No. S.A.10, situated on the north side of the said track; thence north-westwards in a straight line to the boundary stone No. S.A.9, situated at the north-eastern corner of the fencing of the " Pasha Livadhin " garden; thence north-westwards in a straight line to the point of commencement, all which boundary of the said area is shown edged yellow on the Government Survey Plan Serial No. 1492.

*Area " C ".*

The boundary commences at the boundary stone No. S.A.1, situated on the north side of the main road from Troodos to Platres about 38 yards south of the Government hut No. 13, and proceeds north-eastwards in a straight line to the boundary stone No. S.A.12, situated about 100 yards south-west of the Government hut No. 5; thence north-eastwards in a straight line to the boundary stone No. W.D.32, situated about 20 yards west of the Government triangulation point No. K/4, locality " Roudhia "; thence south-westwards in a straight line to the Government 3rd order triangulation point " South Shoulder ", locality " Kaminoudhia "; thence north-westwards in a straight line to the point of commencement, all which boundary of the said area is shown edged blue on the Government Survey Plan Serial No. 1492.

## SECOND SCHEDULE.

The area lying within the following boundary, that is to say:—

The boundary commences at the boundary stone No. S.A.1, situated on the north side of the main road from Troodos to Pano Platres about 38 yards south of Government hut No. 13, and proceeds north-westwards along the said road to the boundary stone No. S.A.2, situated on the south side of the road; thence north-westwards in a straight line to the boundary stone No. S.A.3A, situated near the Government triangulation point No. B/4, locality " Mouyies "; thence north-eastwards in a straight line to the boundary stone No. S.A.4A, situated near the Government triangulation point No. 932/4, locality " Laoni-tou-Evretou "; thence north-westwards in a straight line to the boundary stone No. S.A.5A, situated near the Government triangulation point No. 930/4, locality " Palaea Khora "; thence north-eastwards in a straight line to the boundary stone No. S.A.6A, situated near the Government triangulation point No. 929/4, locality " Khionistra "; thence north-eastwards in a straight line to the boundary stone No. S.A.6B, situated on the north side of the road leading from Troodos to the village of Prodhromos; thence south-eastwards along the said road to a point where it joins a track, locality " Xerolimni "; thence along the said track to the boundary

stone No. S.A.6c; thence north-eastwards in a straight line to the boundary stone No. S.A.6d, situated near the Government triangulation point No. 1929/4, locality "Dhistraton Amiandou"; thence south-eastwards in a straight line to the boundary stone No. S.A.7, situated at the junction of a stream with the stream from "Kannoures" spring, and on the boundary of the Districts of Nicosia and Limassol; thence north-eastwards along the said District boundary to the point where it is cut by the straight line from the Government triangulation point No. 1832/4, locality "Livadhi-tou-Pasha" to the Government 3rd order triangulation point "East Shoulder"; thence southwards in a straight line to the last mentioned point; thence south-westwards in a straight line to the mile post No. 48 on the main road from Nicosia to Troodos, locality "Almyrolivadhon"; thence south-westwards in a straight line to the Government triangulation point No. 941/4, locality "Ayios Mamas"; thence south-westwards in a straight line to the boundary stone No. W.D.32, situated about 20 yards west of the Government triangulation point No. K/4, locality "Roudhia"; thence south-westwards in a straight line to the Government 3rd order triangulation point "South Shoulder", locality "Kaminoudhia"; thence north-westwards in a straight line to the point of commencement, all which boundary of the said area is shown hatched in black on the Government Survey Plan Serial No. 1492.

THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

ORDER IN COUNCIL No. 2489

MADE UNDER SECTION 9A.

*Authority to the Village Health Commission of Yenagra (Famagusta District) to contract a loan.*

In exercise of the powers vested in me by section 9A of the Public Health (Villages) Laws, 1936 to 1948, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. The Village Health Commission of Yenagra (Famagusta District) (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of two hundred and fifty pounds (£250) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

- (a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in six equal annual instalments (comprising sinking fund and interest);
- (b) the Village Health Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate;
- (c) the sum borrowed shall be utilized by the Village Health Commission for the purpose of improving the streets within the village.

2. For the purposes of securing the repayment of the sum due under the loan the Village Health Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all fees, charges and rates now payable or hereafter to become payable to the Village Health Commission under the provisions of the Public Health (Villages) Laws, 1936 to 1948.
