The following bye-laws made by the Village Water Commission of Astromeritis, in the District of Nicosia, and approved by the Commissioner, are published in the Gazette.

BYE-LAWS MADE BY THE VILLAGE WATER COMMISSION OF ASTROMERITIS UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Astromeritis village hereby Cap. 311 make the following bye-laws :-

1. These bye-laws may be cited as the Village Domestic Water Supply (Astromeritis) (Amendment) Bye-laws, 1951, and shall be read as one with the Village Domestic Water Supply (Astromeritis) Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Village Domestic Water Supply (Astromeritis) Bye-laws, 1951.

2. Rule 13 of the principal Bye-laws is hereby amended by the deletion therefrom of the words "30th day of April" and "20th day of July" and the substitution therefor of the words "31st day of August" and "30th day of October" respectively.
