NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 366 in Supplement No. 3 to the *Gazette* of the 18th July, 1951, notice is hereby given that the following land is required by the Governor for the undertaking of public utility mentioned therein (relating to the erection of a power station and other necessary erections and structures, within the District of Nicosia):—

All that area of private land situated in the village of Strovolos, in the District of Nicosia, at the locality Ftana, forming part of plot 77 of the Government Survey Plan No. XXX.5.E.1, and comprising 1 donum and 2 evleks and 800 square feet or thereabouts, more particularly defined as the area coloured red on the plan marked "Central Electrification, Cyprus, Nicosia Sub-station" and dated 21st July, 1951, deposited with the Commissioner, Nicosia.

Any person claiming to have any right or interest in the said land is required within one month from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

The Governor is willing to treat for the acquisition of the said land.

A plan showing the land described above is available for inspection at my office in Nicosia.

No. 409. THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND CONTROL) LAW.
CAP. 157.

NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 4th August, 1951, and the 30th September, 1951, flocks within the area of Pendayia, Nicosia District, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure:

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.
