## NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 10th August, 1951, and the 31st October, 1951, flocks within the areas of the following villages in the District of Larnaca, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure:—

## THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAWS, 1950.

Notice is hereby given that the following lands are required by the Board of the improvement area of Pano Platres for the purpose of constructing a new road, known as the "Krokos" road, within the improvement area:—
