THE WATER SUPPLY (MUNICIPAL AND OTHER AREAS) LAW, 1951.

ORDER IN COUNCIL No. 2505

MADE UNDER SECTION 3.

In exercise of the powers vested in me by section 3 of the Water Supply (Municipal and Other Areas) Law, 1951, I, the Acting Governor, with the advice of the Executive Council, do hereby declare that, as from the 5th day of September, 1951, the area set out in the Schedule hereto shall be an area of supply for the purposes of the said Law and do hereby establish for such area a Board consisting of the following persons:—

1. The Commissioner of Limassol-Paphos, as Chairman;
2. The Water Engineer or his representative;
3. The Accountant-General or his representative;
4. Mr. Nicos D. Solomonides;
5. Ramadan Jemil Effendi;
6. The Municipal Engineer.

SCHEDULE.

Area of Supply.

The area lying within the following boundaries, that is to say:—

The boundary commences at the north-western corner of Plot No. 160 of the Government Survey Plan No. LIV/57 locality "Koutsoullia" and proceeds north-eastwards in a straight line to the most northern point of Plot No. 244/1 of the Government Survey Plan No. LIV/57.2.II, at which point the diversion of the Garyllis river begins; thence north-eastwards in a straight line to the most northern point of Plot No. 21 of the Government Survey Plan No. LIV/51, locality "Throumberi" which point is on the right bank of the Vathias river; thence south-eastwards along the said bank of the said river to the seashore; thence south-westwards along the seashore to the most southern point of Plot

No. 20 of the Government Survey Plan No. LIX/1 which point is on the municipal boundary of Limassol Town; thence northwards along the said municipal boundary to the point of commencement, all which boundary of the said area is shown edged red on the Government Survey Plan Serial No. 1514.

(*Note.*—The above area of supply includes the limits of the Municipal Corporation of Limassol and, to that extent, is declared as an area of supply with the consent of the said Municipal Corporation.)

No. 449. THE ELEMENTARY EDUCATION LAW.

CAP. 203 AND LAW 22 OF 1950.

In exercise of the powers vested in me by section 73 of the Elementary Education Law and on the report of the Director of Education, I, the Acting Governor, do hereby order that the Town Committees or Village Commissions for the Greek-Orthodox Schools of the towns and villages mentioned in the first column of the Schedule hereto shall in their respective towns or villages provide, erect, repair, extend, improve or develop the school buildings, premises, playgrounds, yards, gardens or teachers' dwellings, as the case may be, particulars whereof are given in the second column of the said Schedule.
