THE SPONGE FISHERY LAW. CAP. 162.

ORDER IN COUNCIL No. 2506
MADE UNDER SECTION 12 (1).

In exercise of the powers vested in me by the Sponge Fishery Law, Cap. 162 and with the advice of the Executive Council, I, the Acting Governor, do hereby order as follows:—

1. This Order may be cited as the Sponge Fishery Order, 1951, and shall

come into operation on the 1st January, 1952.

2. In this Order—

"Inspector of Fisheries" means the person or persons appointed from time to time to issue licences under the provisions of the

Sponge Fishery Law.

3. The Inspector of Fisheries shall have power to issue licences to such persons as he may consider to be skilled sponge fishers, to fish for sponge within the territorial waters of Cyprus:

Provided that-

(a) not more than five licences shall be issued in any year for sponge fishing by machine diving apparatus;

(b) he shall otherwise have full discretion to determine the number of

licences to be issued in any year.

4. Licences may be issued at any time and shall be in force until the 31st December of the year in which they are issued.

5. Licences shall be in one of the Forms A, B or C, in the First Schedule hereto. Every such licence shall be personal to the holder (but shall be deemed to cover persons employed by the holder in connection therewith, in accordance with the conditions in his licence) and shall be subject to the provisions of the Sponge Fishery Law and of this Order and to such conditions as the Inspector of Fisheries may impose, to be specified in the licence.

6. The licensee shall always be present in every boat from which sponge fishing is being performed and shall, at all times, produce his licence to the Inspector of Fisheries or to any Customs officer when requested so to do

7. The fees set out in the Second Schedule hereto shall be charged in respect of every licence, permitting the use of one boat only, to fish for sponge:

Provided that as respects any licence issued on or after the 1st day of August in any year there shall be charged only the one-half of such fees.

8. The Sponge Fishery Order, 1937, is hereby revoked.

(b) no trawling or scratching apparatus shall be used. (c) no boat, when at sea, shall carry more than eight persons, excluding any apprentices at the Inspector of Fisheries may allow to accompany the boat under a written permit. (d) no sponge of less than four inches or more than twelve in diameter shall be taken (e) all persons employed by the licensee in connection with sponge fishing shall be thoroughly trained in their respective duties. (f) all sponges taken and landed shall be declared at the nearest Custom House, and the quantity and value shall be declared as taken under this licence. (g) such deposit boats as the Inspector of Fisheries shall deem necessary shall be allowed free of licence duty.
