CAP. 165 AND LAW 10 OF 1950.

APPOINTMENT OF APPROPRIATE AUTHORITY IN IMPROVEMENT AREAS UNDER  
SECTION 3, (2) (b).

In exercise of the powers vested in me by the first proviso to paragraph (b) of section 3 (2) of the Streets and Buildings Regulation Law, I, the Acting Governor, do hereby appoint as appropriate authority—

- (a) for each of the improvement areas set out in the First Schedule hereto a board consisting of the members of the Improvement Board established in each such area, respectively, and functioning for the time being, under the Villages (Administration and Improvement) Laws, 1950 ;
