NOTIFICATION UNDER SECTION 7.

Whereas by Notification published under No. 366 in Supplement No. 3 to the *Gazette* of the 18th July, 1951, I, the Acting Governor, declared the erection within the District of Nicosia of a power station and such other erections or structures as may from time to time be considered necessary in connection with the scheme mentioned in the Notification published under No. 186

in Supplement No. 3 to the *Gazette* of the 3rd July, 1947, to be an undertaking of public utility;

And whereas the Commissioner of Nicosia and Kyrenia by notice published under No. 408 in Supplement No. 3 to the *Gazette* of the 8th August, 1951, gave particulars of the properties required in connection with the aforesaid undertaking;

And whereas the Commissioner forwarded to the Governor the required recommendations, plan and particulars, no objections having been made;

And whereas I, the Acting Governor, have approved the plan and particulars submitted and have considered it expedient, having regard to all the circumstances of the case, that the properties in question be acquired:

Now, therefore, in exercise of the powers vested in me by section 7 of the Land Acquisition Law, I, the Acting Governor, do hereby sanction the acquisition under the provisions of the said Law of the properties particulars whereof are specifically set out in the notice of the Commissioner of Nicosia and Kyrenia hereinbefore mentioned.

NOTIFICATION UNDER SECTIONS 2, 3 AND 5.

J. FLETCHER-COOKE,

Whereas it has been represented to me that it is desirable in the public interest to align and improve that part of the public road between Nicosia and Famagusta, which is situated between the 3rd and 4th milestones from Famagusta in the District of Famagusta, and that lands are needed for this purpose;

Now, therefore, in exercise of the powers vested in me by section 2 of the Land Acquisition Law, I, the Acting Governor, do hereby declare the alignment and improvement of the aforesaid part of the public road to be an undertaking of public utility and do hereby, by virtue of the powers vested in me by section 3 of the said Law, authorize the carrying out of the said undertaking under the provisions of the said Law and do hereby, by virtue of the powers vested in me by section 5 of the said Law, entrust the Director of Public Works with the supervision and effectuation of the said undertaking.
