

No. 49. THE LAND ACQUISITION LAWS, 1899 TO 1947.**NOTICE UNDER SECTION 5.**

With reference to the Notification published under No. 12 in Supplement No. 3 to *Gazette* No. 3538 of 10th January, 1951, notice is hereby given that the following land is required by the Governor for the undertaking of public utility mentioned therein :—

All that area of land with the trees thereon situated in the village of Ayia Phyla, in the District of Limassol, at the locality "Vourna tou Pourouti" comprising 2 donums, 3 evleks and 640 square feet or thereabouts and forming part of plot No. 129 of the Government Survey Plan No. LIV.50 more particularly defined as the area hatched in yellow on the plan numbered as bl. 1 in the file of the Commissioner of Limassol No. 294/50.
