## No. 529. THE ELEMENTARY EDUCATION LAW.

CAP. 203 AND LAW 22 OF 1950.

ORDER MADE UNDER SECTION 89.

Whereas the Governor has, under section 73 of the Elementary Education Law, ordered the Village Commissions for Moslem Schools mentioned in the second column of the Schedules hereto to provide school buildings, premises, playgrounds, yards, gardens or teachers' dwellings;

And whereas the necessary estimates and plans have been prepared under section 74 of the above-mentioned Law;

And whereas loans amounting to the sums mentioned in the third column of the Schedules hereto have, under section 72 (1) and (2), been raised to meet the expense of providing such buildings as aforesaid:

Now, therefore, in pursuance of the powers vested in me by section 89 of the Elementary Education Law, I, the Acting Governor, do hereby order that in order to provide for the annual interest and sinking fund in respect of the loans aforesaid the sums of money mentioned in the fourth column of the said Schedules hereto be recovered from the Moslem taxpayers of the villages mentioned in the second column of the said Schedules in the manner prescribed by section 95 of the above Law.

And whereas loans amounting to the sums mentioned in the third column of the Schedule hereto have, under section 72 (1) and (2) of the said Law, been raised to meet the expense of providing such buildings as aforesaid:

Now, therefore, in pursuance of the powers vested in me by section 89 of the Elementary Education Law, I, the Acting Governor, do hereby order that in order to provide for the annual interest and sinking fund in respect of the loans aforesaid the sums of money mentioned in the fourth column of the said Schedule hereto be recovered from the Maronite taxpayers of the villages mentioned in the second column of the said Schedule in the manner prescribed by section 96 of the said Law.
