## NOTICE No. 283 UNDER CLAUSE 13.

The Schedule is hereby amended by the deletion therefrom of Part 74 and the substitution therefor of the following Part, with effect from the 31st October, 1951.

## “PART 74.—METHYLATED SPIRITS.

Type of Methylated Spirit	Retail Price	Wholesale Price
Denaturated or methylated spirits (locally known as Spirito tou Kaminetou) of a minimum Strength of 80° Gay Lussac or 40° over proof ‘Sikes’s Hydrometer’.	4s. & 6p. per oke.	4s. & 4p. per oke.

## In this Part of the Schedule—

the term ‘oke’ means one-eighth of a kouza or  $1\frac{1}{8}$  quarts (as defined in the Weights and Measures Law, Cap. 182);

the term ‘wholesale’ means sale or purchase of methylated spirits in quantities of not less than 10 okes or  $1\frac{1}{4}$  kouzas at any one time or at any single transaction.

*Modification.*—Provided that where methylated spirits are sold in any village outside a radius of 3 miles of a Commissioner’s office, there may be added to the maximum retail price two piastres per oke.”

## CAP. 53.

## ORDER UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Burials Law and delegated to me by Notification No. 172 published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I, Warren Frederick Martin Clemens, Commissioner of the Districts of Nicosia and Kyrenia, do hereby order that an additional burial ground shall be provided, under the provisions of the said Law, for use by the Orthodox-Christian community of the village of Palouriotissa, in the Nicosia District.
