No. 60. THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW, 1948.

BYE-LAWS MADE BY THE WATER COMMISSION OF GALATA VILLAGE UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, 1948, the Water Commission of Galata village hereby make the following bye-laws :—

1. These bye-laws may be cited as the Village Domestic Water Supply (Galata) Bye-laws, 1951.
- 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this bye-law, the Village Domestic Water Supply (Elea) Bye-laws, 1950, published in the *Gazette* of 1st November, 1950, shall—
 - (a) be deemed to be bye-laws made by the Water Commission of Galata and to be incorporated herein, and
 - (b) apply to the village of Galata.
- (2) The bye-laws set out in Part I of the Schedule hereto shall be substituted for the corresponding bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950.
- (3) Those bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950, mentioned in Part II of the Schedule hereto, shall not apply to the village of Galata.
