CAP. 175.**

**No. 606. THE PUBLIC HEALTH (VILLAGES) LAW.
CAP. 142.**

The following rules made by the Village Health Commission of Marathovouno, in the District of Famagusta, and approved by the Commissioner, are published in the *Gazette*.

**RULES MADE BY THE VILLAGE HEALTH COMMISSION OF
MARATHOVOUNO UNDER SECTION 9.**

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Marathovouno hereby make the following rules:—

1. These rules may be cited as the Village Health (Marathovouno) (Amendment) Rules, 1951, and shall be read as one with the Village Health (Marathovouno) Rules, 1938 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Marathovouno) Rules, 1938 to 1951.

2. Rule 20 of the principal Rules is hereby repealed and the following rule substituted therefor:—

"Rule 20.—(1) The following fees shall be paid by the owner or the person slaughtering any animal in the slaughter-house:—

	<i>s.</i>	<i>p.</i>
(a) For every bullock, camel, cow or ox	2	0
(b) For every goat, sheep, kid or lamb	1	0
(c) For every swine	2	0

(2) Every such fee shall be paid to the Inspector."
