

**No. 615. THE MOTOR CAR REGULATIONS, 1951.****APPOINTMENTS UNDER REGULATION 4.**

In exercise of the powers vested in me under regulation 4 of the Motor Car Regulations, 1951, I do hereby appoint—

- (a) the Officer in charge of the Police Traffic Branch, Nicosia, as Deputy Registrar to carry out and exercise all the duties and powers vested in the Registrar under the aforementioned regulations, except the power of the Registrar under regulation 40 ;
- (b) the Police Officers for the time being in charge of the Limassol, Famagusta, Larnaca, Paphos and Kyrenia Police Divisions to carry out the following duties vested in the Registrar under the aforementioned regulations in their respective Divisions :—
  - (i) to issue temporary licences under regulation 42 ;
  - (ii) to issue learners' licences under regulation 38 (1) ;
  - (iii) to renew driving licences under regulation 37 ;
  - (iv) to issue special permits for projecting loads under regulation 45 (n) and for excess passengers under regulations 46 (g) and 47.

**No. 616. THE MOTOR CAR REGULATIONS, 1951.****TYPES OF HORNS APPROVED BY THE REGISTRAR UNDER REGULATION 45 (e).**

In exercise of the powers vested in me by regulation 45 (e) of the Motor Car Regulations, 1951, I do hereby approve of the following types of horns to be carried by all motor cars :—

- (a) Not more than two electric horns sounding a single tuned wind tone.
- (b) Bulb horns which give out a single sound when the bulb is pressed but which do not make any sound when the bulb is released.

2. The Notice dated 29th March, 1946, published under Notification No. 225 in the *Gazette* No. 3236 of the 30th March, 1946, is hereby cancelled.

CAP. 53.****ORDER UNDER SECTION 2.**
