THE COURTS OF JUSTICE (SUPPLEMENTARY PROVISIONS) LAW, 1949.

RULES OF COURT, 1951.

In exercise of the powers vested in the Governor by the Courts of Justice (Supplementary Provisions) Law, 1949, and the Courts of Justice Laws, 1935 to 1947, and of every other power enabling him in this behalf, and with the advice and assistance of the Chief Justice, His Excellency the Governor has been pleased to make and hereby makes the following rules :—

1. These rules may be cited as the Rules of Court, 1951, and shall be read as one with the Rules of Court, 1938 to 1946 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may be cited together as the Rules of Court, 1938 to 1951.

2. Rule 3 in Order 1 of the principal rules is hereby amended by the deletion of the words "taking of affidavits or" in the fourth line of the definition "The Registrar".

No. 66. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTIFICATION UNDER SECTION 6.

Whereas by Notification dated the 13th day of October, 1950, and published under No. 438 in Supplement No. 3 to the *Gazette* of the 18th October, 1950, the Governor declared under sections 2 and 3 of the Land Acquisition Laws, 1899 to 1947 (hereinafter referred to as "the Laws") the erection in Limassol of public offices for the Labour Exchange and the Tourist Office and the development of the area adjoining thereto for the promotion of tourism to be an undertaking of public utility;

And whereas the Commissioner of Limassol by notice dated the 26th day of October, 1950, and published under Notification No. 472 in Supplement No. 3 to the *Gazette* of the 8th November, 1950 (hereinafter referred to as "the notice") gave particulars of the immovable properties required in connection with the aforesaid undertaking;

And whereas, in compliance with the Laws, the Commissioner forwarded to the Governor the required recommendations, plans and particulars, together with the objections made;

And whereas the Governor has approved the plans and particulars submitted and considered it expedient, having regard to all the circumstances of the case, that the immovable properties in question be acquired:

Now, therefore, in exercise of the powers vested in me by section 6 of the Laws, I, the Governor, do hereby sanction the acquisition, under the provisions of the Laws, of the immovable properties, situated in Limassol, particulars whereof are specifically set out in the notice.
