

No. 81. THE SHOP ASSISTANTS LAWS, 1942 AND 1945.

ORDER IN COUNCIL No. 2462

In exercise of the powers vested in me by section 19 of the Shop Assistants Laws, 1942 and 1945, I, the Governor, with the advice of the Executive Council, do hereby order that the Second Schedule to the said Laws be amended by the addition thereto immediately after item 14 of the following item :—

“ 15. The sale of any goods in any premises or place on such date or dates and at such time or times as the Commissioner may declare by notice in the *Gazette* on occasions on which groups of persons visit the Colony for a period of stay not exceeding one week.”

THE CO-OPERATIVE SOCIETIES LAWS, 1939 AND 1946.

RULES MADE UNDER SECTION 53.

In exercise of the powers vested in me by section 53 of the Co-operative Societies Laws, 1939 and 1946, I, the Governor, with the advice of the Executive Council, do hereby make the following rules :—

1. These rules may be cited as the Co-operative Societies (Amendment) Rules, 1951, and shall be read as one with the Co-operative Societies Rules, 1940 and 1947 (hereinafter referred to as “the principal Rules”), and the principal Rules and these rules may together be cited as the Co-operative Societies Rules, 1940 to 1951.

2. For the definition of “Law” in rule 2 of the principal Rules the following definition shall be substituted :—

“ ‘Law’ means the Co-operative Societies Law, 1939, or any other Law amending or substituted for the same ; ”.

3. For rule 29 of the principal Rules the following rule shall be substituted :—

“ 29. The first meeting of members shall be held immediately or not later than one month after the receipt of the Certificate of Registration of the Society in the Form No. 5 and a Committee shall be elected thereat as in rule 39 provided.”

4. Rule 39 of the principal Rules is hereby amended as follows :—

(a) By the insertion therein immediately after paragraph (a) thereof of the following paragraph :—

“ (b) If any question is raised as to the method of conducting the election under this rule or the validity thereof such question shall be decided by the Registrar whose decision shall be final.” ;

(b) By re-lettering the existing paragraph (b) thereof as paragraph (c), by the substitution for the full stop at the end thereof of a colon

and the insertion therein immediately thereafter of the following proviso :—

“ Provided that in a registered Society, the area of operations of which extends over more than one district, the committee shall consist of such larger number of members as may be provided in the bye-laws.”

5. Rule 48 (1) of the principal Rules is hereby amended by the substitution for the full stop at the end thereof of a colon and the insertion therein immediately thereafter of the following further proviso :—

“ Provided further that, when more than two vacancies occur at the same time, substitutes shall be elected by a Special General Meeting.”

6. Rule 54 of the principal Rules is hereby amended by the deletion therefrom of paragraph (2) thereof, paragraph (1) thereof remaining as the only unnumbered paragraph of rule 54.

7. For rule 101 of the principal Rules the following rule shall be substituted :—

“ 101.—(1) The procedure to be followed by the Registrar in deciding a dispute under the provisions of section 52 (2) (a) of the Law or an appeal under the provisions of sub-section (4) of the same section shall be, as nearly as possible, similar to that followed by a Court of Law in trying a civil case and the provisions of rule 100 shall apply *mutatis mutandis*.

(2) An appeal against an award of the arbitrator or arbitrators under the provisions of section 52 (3) of the Law shall be made by notice of appeal in the form set out in the Second Schedule hereto, filed with the Registrar together with a copy of the award appealed against within twenty-one days from the date of such award and delivered to any party affected by the appeal within the same period.”

8. The principal Rules are hereby amended by the insertion therein immediately after the Schedule thereto of the following Schedule, the heading of the existing Schedule being amended by the insertion therein of the word “ FIRST ” before the word “ SCHEDULE ”.
