The following bye-laws made by the Village Water Commission of Spilia, in the District of Nicosia, and approved by the Commissioner, are published in the *Gazette*.

BYE-LAWS MADE BY THE VILLAGE WATER COMMISSION OF SPILIA UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Spilia village hereby make the following bye-laws :--

1. These bye-laws may be cited as the Village Domestic Water Supply (Spilia) (Amendment) Bye-laws, 1952, and shall be read as one with the Village Domestic Water Supply (Spilia) Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these byo-laws may together be cited as the Village Domestic Water Supply (Spilia) Bye-laws, 1951 and 1952.

2. Rule 12 of the principal Bye-laws is hereby deleted and the following Rule substituted therefor: "The Water Commission shall, in every year, fix a uniform rate not exceeding eighty shillings to be paid by every householder in the village, for the maintenance of the water supply".
