**BYE-LAWS MADE BY THE VILLAGE WATER COMMISSION OF POTAMI
UNDER SECTION 29.**

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Potami village hereby make the following bye-laws:—

1. These bye-laws may be cited as the Village Domestic Water Supply (Potami) (Amendment) Bye-laws, 1952, and shall be read as one with the Village Domestic Water Supply (Potami) Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Village Domestic Water Supply (Potami) Bye-laws, 1951 and 1952. *Gazette*:

2. Rule 12 of the principal Bye-laws is hereby deleted and substituted by the following rule:—
