THE GAME AND WILD BIRDS PROTECTION LAW.

CAP. 98 AND LAW 23 OF 1950.

ORDER IN COUNCIL No. 2529

MADE UNDER SECTION 6 (1) (a).

In exercise of the powers vested in me by section 6 (1) (a) of the Game and Wild Birds Protection Law, and of every other power hereunto enabling, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Game and Wild Birds (Shooting of Wild Birds) (Amendment) Order, 1952, and shall be read as one with the Game and Wild Birds (Shooting of Wild Birds) Orders, 1937 and 1941, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Game and Wild Birds (Shooting of Wild Birds) Orders, 1937 to 1952.

2. The area within the Paphos District set out in the Schedule to the principal Order is hereby deleted and the following area substituted therefor:—

"AREA—contained within the following boundary line:—

The boundary commences at the mouth of the Vrexis river and proceeds upstream along the said river to the junction of the Dhyplargaki and the Katarakhtis rivers; thence upstream along the last mentioned river to the bridge on the road from the village of Khlorakas to Ktima town; thence northwards along the said road to its junction with a road leading to the villages of Emba and Tala; thence northwards along the said road to the village of Tala; thence north-eastwards along the track from the said village to Ayios Neophytos Monastery; thence southwards along the road from the said monastery to the village of Trimithousa Paphos; thence south-eastwards along the road from the said village, across the asphalt road from Polis village to Ktima town and through the village of Mesoyi to the village of Mesakhorio; thence south-eastwards and eastwards along a track from the said village and through the villages of Armou, Marathounda and Episkopi to the junction of the said track with the Ezuza river;

thence south-westwards along the said river to the seashore; thence north-westwards along the seashore to the point of commencement, all which said boundary is shown delineated in red on the Government Survey Plan Serial No. 1530."

THE CUSTOMS LAW.

CAP. 292 AND LAWS 2 OF 1950 AND 5 OF 1952.

In exercise of the powers vested in me by section 52 of the Customs Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Cinematograph Films (Reduction of Rates of Import) Order, 1952.

2. From and after the 16th day of March, 1952, cinematograph films developed shall be charged at a reduced rate of import duty, that is to say, $0\frac{3}{4}p.$ per yard and $1\frac{1}{2}p.$ per yard preferential and general tariff, respectively, instead of $2\frac{1}{4}p.$ and $4\frac{1}{2}p.$ per foot, respectively.

THE LAND ACQUISITION LAW.

CAP. 233.

NOTIFICATION UNDER SECTION 7.

Whereas by Notification published under No. 68 in Supplement No. 3 of the *Gazette* of the 13th February, 1952, the Governor declared the establishment and maintenance on a better basis of an airfield and camps and other installations appurtenant thereto in or near the villages of Yerolakkos, Ayios Dhometios, Engomi, Kato Lakatamia and Palcometokho in the District of Nicosia, to be an undertaking of public utility;

And whereas the Commissioner of Nicosia and Kyrenia by notice published under No. 99 in Supplement No. 3 of the *Gazette* of the 27th February, 1952, gave particulars of the lands required in connection with the aforesaid airfield and camps and other installations appurtenant thereto;

And whereas the Commissioner forwarded to the Governor the required recommendations, plan and particulars, together with the objections made;

And whereas, I, the Governor, have approved the plan and particulars submitted and have considered it expedient, having regard to all the circumstances of the case, that the lands in question be acquired:

Now, therefore, in exercise of the powers vested in me by section 7 of the Land Acquisition Law, I, the Governor, do hereby sanction the acquisition under the provisions of the said Law of the lands particulars whereof are specifically set out in the notice of the Commissioner of Nicosia and Kyrenia hereinbefore mentioned.
