"7. The sale of refreshments for consumption on the premises or by hawkers.";

(b) by the insertion in each one of the said Schedules, immediately after item 7, of the following item:—

"7A. The sale, in pavilions (commonly known as "kiosks"), of sweets, chocolates, biscuits, fresh and dry fruit, newspapers and periodicals and liquid refreshments, other than intoxicating liquors as defined in the Sale of Intoxicating Liquors Law.
