THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1951), I hereby order as follows:—

1. This Order may be cited as the Supplies and Services (Wheat and Barley Control) Order, 1952.

2. In this Order—

"authorized purchaser" means any person or body of persons duly authorized by the Controller to purchase wheat or barley, or both; "Controller" means an officer appointed by the Governor as Controller

- of Wheat and Barley;
  "producer" means any person who since the 1st day of September, 1951, has cultivated and produced any wheat or barley or both, either by his own labour or through his agents or servants.
- 3. From and after the 3rd day of May, 1952, no person shall purchase any wheat or barley, whether imported or locally grown, save under a written permit issued by the Controller or any person authorized by him in that behalf.
- 4. Save under a written permit issued by the Controller or any person authorized by him in that behalf, from and after the 3rd day of May, 1952, no producer shall sell any wheat or barley save to an authorized purchaser.
- 5. No person who is not a producer or authorized purchaser or the holder of a permit issued under clause 3 or 4 of this Order, shall have in his possession or under his control any wheat or barley in excess of the normal requirements for his household for one month.
- 6. Every person shall permit such person as the Controller or the Commissioner of the District may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.
- 7. Any person who acts in contravention of or fails to comply with any of the provisions of this Order is liable to the penalties prescribed in the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.
- 8. The Supplies and Services (Wheat Control) Order, 1949, is hereby Gazette: revoked without prejudice to anything done or left undone thereunder.
