THE WATER SUPPLY (MUNICIPAL AND OTHER AREAS)  
LAW, 1951.

NOTICE UNDER SECTION 18 (2).

Notice is hereby given that the following immovable property is required by the Water Board of Nicosia for the supply of water within its area of supply:

THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.  
CAP. 311 AND LAW 28 OF 1951.

(Section 12 (2).)

Notice is hereby given that the immovable property, as hereinafter, is required by the Water Commission of Ayios Tykthonas, in connection with a scheme for the supply and/or maintenance of a supply of water for the domestic purposes of the inhabitants of the said village under the provisions of the Water (Domestic Purposes) Village Supplies Law.
