

No. 267. THE WELLS LAW.
CAP. 312 AND LAW 19 OF 1951.

NOTICE UNDER SECTION 3A (2).

Whereas His Excellency the Governor, being satisfied that special measures for the conservation of water in the areas set out in the Schedule hereto are necessary in the public interest, proposes to make an Order in respect of such areas under section 3A of the Wells Law :

Now, therefore, by the direction of His Excellency the Governor notice is hereby given that the particulars of the proposed Order shall be as set out in the Schedule hereto and that a copy of the draft of the proposed Order and every relevant map and plan may be inspected at the office of the Commissioner of the District in which the area affected is situated during office hours and free of charge during a period of fourteen days of the publication of this notice in the *Gazette* and that any person may, within the same period, by notice addressed to the Commissioner of the District in which the area affected is situated, object to the making of the Order.

SCHEDULE.

Defined Areas.

1. In the villages of Dherinia, Phrenaros and Avgorou, in the District of Famagusta, the area within the following boundary, that is to say :—

The boundary commences at milepost No. 4 on the Famagusta-Larnaca main road and proceeds eastwards in a straight line to a road junction, which junction is on the road leading from the village of Dherinia to the Larnaca-Famagusta main road ; thence south-eastwards along the said village road, which road forms the south-western boundary of the "Famagusta Underground Water Conservation Area No. 3", to its junction with a footpath, which junction is 400 yards approximately west-north-west from the built-up area of the said village ; thence south-westwards in a straight line to the north-eastern corner of the "Phrenaros Underground Water Conservation Area No. 4", thence westwards along the northern boundary of the said area to the north-western corner of the said area, locality "Mosphili Noshou" ; thence north-eastwards in a straight line to the point of commencement all which boundary is more particularly delineated on a plan marked Serial No. 1550 signed by the Commissioner of Famagusta bearing the date 20th May, 1952, and deposited at the office of the Commissioner, Famagusta.

2. In the villages of Laxia, Dhali, Xeri, Perakhorio and Nisou, in the District of Nicosia, the area within the following boundary, that is to say :—

The boundary commences at the most northern point of plot No. 107 of Block E, Laxia village, locality "Asprokhomata", which point is at a corner of the bridge carrying the Nicosia-Limassol main road over the river Ayios Yeoryios and proceeds eastwards in a straight line to the most northern point of plot No. 213 of Block F of the said village, which point is on a track leading from the said main road to the village of Potamia, thence south-eastwards along the said track to the bridge carrying the said track over the river Almyros ; thence south-westwards along the left bank of the said river to a track leading from the said main road to the village of Dhali ; thence southwards along the said track to its junction with the village road leading from the said main road to the said village, locality "Ayiasmata" ; thence north-westwards along the said village road to its junction with the said main road ; thence north-westwards (across the said main road) along a track to the most northern point of plot No. 90 of Block F, Perakhorio village, locality "Mesovounia", which point is on the boundary between the said village and the village

of Xeri; thence south-westwards along the said boundary to the south-western corner of plot No. 253 of the said block, which corner is on the boundary between the said village the village of Ayia Varvara; thence south-westwards along the said boundary to the most southern point of plot No. 308 of Block H, Xeri village, locality "Kaphkalla tis Khalis"; thence northwards in a straight line to the most northern point of plot No. 15 of Block F of the said village, locality "Kokkinorashidhia", which point is on the boundary between the said village and the village of Laxia; thence northwards along the said boundary to the most western point of plot No. 424, of Block C, Laxia village, locality "Laxia tou Kambanelli", which point is at the junction of the boundaries between the said village and the villages of Xeri and Kato Lakatamia; thence north-eastwards in a straight line to the point of commencement all which boundary is more particularly delineated on a plan marked Serial No. 1544 signed by the Commissioner of Nicosia bearing the date 26th March, 1952, and deposited at the office of the Commissioner, Nicosia.

3. In the villages of Klavdhia and Tersephanou, in the District of Larnaca, the area within the following boundary, that is to say:—

The boundary commences at the most northern point of plot No. 120 of the Government Survey Plan No. L/5, locality "Tremythos", which point is on the boundary between the villages of Kalokhorio and Klavdhia and proceeds south-eastwards along the said village boundary to the most southern point of plot No. 67 of the said plan; thence south-eastwards along the boundaries of and including plots Nos. 136, 222 and 245/1 of the said plan to the most eastern point of the last mentioned plot, which point is on the Larnaca-Limassol main road; thence eastwards (across the said road) and south-eastwards along the boundaries of and including plots Nos. 245/2, 297, 296 and 318 of the said plan, plots Nos. 71, 63, 60, 58, 81, 92, 87, 90, 106, 108, 110, 114 and 210 of the Government Survey Plan No. L/13, locality "Eski Jami", plots Nos. 133/2, 133/1 and 133/3 of the Government Survey Plan No. L/14, locality "Ay. Yeorghoudhin", to the most eastern point of plot No. 47.3 of the Government Survey Plan No. L/22, which point is at a junction of tracks, locality "Pervolia"; thence westwards (across the river Tremythos) and southwards along a track to the point where another track joins it, locality "Arpera Chiftlik"; thence north-westwards along the last mentioned track to the most eastern point of plot No. 217 of the Government Survey Plan No. L/13, locality "Arkaji tou Kouphou"; thence north-westwards along the boundaries of and including the said plot and plots Nos. 213, 198, 195, 143, 146, 147, 150, 157, 156, 44, 41, 39 and 32 of the said plan, locality "Mesdraonou", to the most western point of the last mentioned plot, which point is on the said road; thence northwards along the said road to the south-western corner of plot No. 25/2 of the said plan; thence westwards (across the said road) and northwards along the boundaries of and including plots Nos. 25/1, 310, 309, 303, 237, 229, 226, 132, 133, 127, 124, 117, 118 and 119 of the Government Survey Plan No. L/5, locality "Tremythos", to the most northern point of the last mentioned plot, which point is on the said river; thence southwards (across the said river) to the point of commencement all which boundary is more particularly delineated on a plan marked Serial No. 1541 signed by the Commissioner of Larnaca bearing the date 4th March, 1952, and deposited at the office of the Commissioner, Larnaca.
