NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 15th July and the 30th October, 1952,

flocks within the area of Elea, Nicosia District, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.

THE TREE PLANTING (VILLAGE AREAS) LAW.

CAP. 175.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Agros in the District of Limassol on the 20th May, 1951, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Agros ;

And whereas the Mukhtar of the said village of Agros has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law :

Now, therefore, I, the Commissioner of the District of Limassol, having approved the said report, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Agros.

SCHEDULE.

Area " A ".

The area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 474 of the Government Survey Plan No. XXXVIII/49, locality " Mersinoudhia ", which point is on the boundary between the districts of Limassol and Nicosia and proceeds south-eastwards along the said boundary to the north-eastern corner of plot No. 476 of the said plan ; thence southwards along the boundaries of, and including, the said plot, plots Nos. 483; 506 and 519 of the said plan to the north-eastern corner of the last mentioned plot, which corner is on a stream ; thence southwards along the said stream to the south-eastern corner of plot No. 779 of the said plan, which corner is on the main road from Troodos to the village of Palekchori ; thence south-westwards along the said road to the most southern point of plot No. 835 of the said plan, locality " Livadhi " ; thence southwards (across the said road) along the boundaries of, and including, plots Nos. 974, 975, 976, 970, 969, 968, 1210 and 1211 of the said plan, locality " Kokkinoyia ", plots Nos. 31, 32, 33, 34, 37, 265 (part of), 263 and 260 of the Government Survey Plan No. XXXVIII/57, locality " Stavro ", to the most southern point of the last mentioned plot, which point is on a stream ; thence north-westwards along the said stream to the south-western corner of plot No. 267 of the said plan, locality " Mersinia " ;
