THE POST OFFICE LAW. CAP. 281.

ORDER IN COUNCIL No. 2542 MADE UNDER SECTION 7.

A. B. WRIGHT,

Governor.

In exercise of the powers vested in me by section 7 of the Post Office Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows :—

1. This Order may be cited as the Parcels Post (Rates of Postage) (Amendment) Order, 1952, and shall be read as one with the Parcels Post (Rates of Postage) Order, 1952 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Parcels Post (Rates of Postage) Orders, 1952.

- 2. The Schedule to the principal Order is hereby amended as follows:—
 (a) by the addition thereto in its alphabetical order of the new entry set out in the First Schedule hereto;
- (b) by the deletion therefrom of the entries relating to the countries shown in the Second Schedule hereto and the substitution therefor of the entries relating to the same countries set out in the Second Schedule hereto.

3. This order shall come into operation on the 9th day of July, 1952.

THE SHOP ASSISTANTS LAW. CAP. 159 AND LAW 8 OF 1952.

ORDER IN COUNCIL No. 2544 MADE UNDER SECTION 19.

Governor.

In exercise of the powers vested in me by section 19 of the Shop Cap. 159 Assistants Law, I, the Governor, with the advice of the Executive Council, 8 of 1952 do hereby order as follows :---

1. This Order may be cited as the Shop Assistants (Afternoon Week-day) Closing Order, 1952.

2. The day set out in the third column of the Schedule hereto is hereby appointed as the day in every week on which the class of shops set out in the second column of the said Schedule, corresponding to such day, shall be closed in each one of the towns or villages set out in the first column of the said Schedule corresponding to such class of shops and day :

Provided always that nothing in this Order contained shall apply to any shop solely kept open for one or more of the purposes set forth, for the time being, in the First Schedule to the Shop Assistants Law,
