ORDER IN COUNCIL No. 2549
MADE UNDER SECTION 124 (a) (i).

Authority to the Council of the Municipal Corporation of Athienou to contract a loan.

In exercise of the powers vested in me by section 124 (a) (i) of the Municipal Corporations Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows :—

1. The Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Athienou (hereinafter referred to as "the Municipal Corporation") shall be at liberty to borrow from the Athienou Co-operative Credit Society (hereinafter referred to as "the Lender") the sum of three hundred pounds (£300) without interest, subject to the following terms and conditions, that is to say :—

- (a) the sum borrowed shall be repayable by the Municipal Corporation to the Lender in ten equal annual instalments, the first instalment being payable one year after the date of borrowing and all subsequent instalments being payable on the corresponding date of each year following until final repayment ;
- (b) the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual sum payable as aforesaid in the year to which such estimates relate ;
- (c) the sum borrowed shall be utilized by the Municipal Corporation for the establishment of a Nursery Garden at Athienou.

2. For the purpose of securing the repayment of the sum under the loan, the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.

THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)
LAWS, 1950.

ORDER AND DIRECTIONS UNDER SECTIONS 4 AND 57.

In exercise of the powers vested in me by sections 4 and 57 of the Villages (Administration and Improvement) Laws, 1950 (hereinafter referred to as "the 1950 Laws"), I, the Governor, do by this order declare that the village of Aya Phyla in the district of Limassol (hereinafter referred to as "the village"), to which the provisions of the Public Health (Villages) Law (hereinafter referred to as "the Public Health Law") at present apply,

be an improvement area for the purposes of the 1950 Laws, and I further do hereby direct that—

- (a) the Village Health Commission, constituted under the provisions of the Public Health Law in respect of the village, shall be deemed to be a Board established under and for the purposes of the 1950 Laws in respect of the village and shall continue to function until a new Board is established in its place as in the 1950 Laws provided ;
- (b) all Rules made under the provisions of the Public Health Law, in respect of the village, shall be deemed to be bye-laws made under the provisions of the 1950 Laws in respect of the village, in so far as they are not inconsistent with the provisions of the last mentioned Laws, and such Rules shall remain in force until revoked or replaced by bye-laws made under the provisions of the 1950 Laws.

No. 289. THE PROBATION OF OFFENDERS LAW, 1952.

REGULATIONS MADE UNDER SECTION 13 (b).

In exercise of the powers vested in me by section 13 (b) of the Probation of Offenders Law, 1952, I, the Governor, do hereby make the following regulations :—

1. These regulations may be cited as the Probation of Offenders (Form of Records) Regulations, 1952.
2. Each probation officer shall keep—
 - (a) a register of all probationers under his supervision in the form set out in the Schedule hereto ;
 - (b) a record file for each probationer which shall contain—
 - (i) all papers relating to the probationer received from the Court making the probation order ;
 - (ii) a report upon the circumstances or home environment of the probationer ;
 - (iii) any report relating to the physical and mental health of the probationer ;
 - (iv) the social record of the probationer during the probation period including dates and times of visits received from or paid to the probationer and failures of the probationer to comply with any of the requirements of the probation order ;
 - (v) any other information received which is relevant to the study and treatment of the probationer or to the home environment of the probationer ; and
 - (vi) records of the activities of the probation officer in respect of each probationer and the behaviour of the probationer which shall be summarized in the form of a quarterly report and submitted to the supervising court from time to time as the court may require.
