1. These rules may be cited as the Irrigation Division of Kochati and Ayia Varvara (Amendment) Rules, 1952, and shall be read as one with the Irrigation Division of Kochati and Ayia Varvara Rules, 1939 and 1948 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Irrigation Division of Kochati and Ayia Varvara Rules, 1939 to 1952.

2. Paragraph (2) of rule 4 of the principal Rules is hereby amended by the deletion therefrom of the word "March" and the substitution therefor of the word "August".

3. Rule 6 of the principal Rules is hereby amended by the deletion therefrom of the words "28th February" and the substitution therefor of the words "31st July". (M.P. 1240/51.)

**DISSOLUTION OF THE IRRIGATION ASSOCIATION OF MATHIATI ("BAMBAKA,**  
**TRIMITHIA, TEKNEDJIK AND BURBULLI" WATER).**

Whereas an application was made to the Commissioner of Nicosia signed by not less than two-thirds of the proprietors requesting that the Irrigation Association of Mathiati ("Bambaka, Trimithia, Teknedjik and Burbulli" Water) (hereinafter referred to as "the Association") be dissolved;

And whereas at a meeting of the proprietors of the Association held under Rule 18 of the Irrigation of Mathiati ("Bambaka, Trimithia, Teknedjik and Burbulli" Water) Rules, 1950 (hereinafter referred to as "the Rules") at the village of Mathiati on the 6th July, 1952, it was decided by the requisite majority of the voters present thereat that the said Irrigation Association should be dissolved:

Now, therefore, it is hereby notified that the Association has been dissolved accordingly as from the 6th day of July, 1952, subject to the reservations and exceptions contained in the Rules. (M.P. 1925/50.)
