## BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF ZYYI.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950, the Improvement Board of Zyyi hereby make the following bye-laws:—

1. These bye-laws may be cited as the Villages (Administration and Improvement) (Zyyi) (Amendment) Bye-laws, 1952, and shall be read as one with the Villages (Administration and Improvement) (Zyyi) Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) (Zyyi) Bye-laws, 1951 and 1952.

2. The Second Appendix to the principal Bye-laws is hereby amended by the deletion therefrom of the figures "110-120".

The above bye-laws have been approved by the Colonial Secretary.

## CAP. 111.

1. These rules may be cited as the Irrigation Division of Ayios Epiphanos (Dagh) (Amendment) Rules, 1952, and shall be read as one with the Irrigation Division of Ayios Epiphanos (Dagh), Rules, 1944, (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Ayios Epiphanos (Dagh) Rules, 1944 and 1952.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "ten shillings" and the substitution therefor of the words "eighty shillings".

## No. 37. THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAW, 1949.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Law, 1949, the following Rules made by the Committee of the Irrigation Association of Ayii Vavatsinias No. 2 ("Diploma" Water), in the District of Larnaca, are published in the *Gazette*.

## IRRIGATION ASSOCIATION OF AYII VAVATSINIAS NO. 2 ("DIPLOMA" WATER).

*Rules.*

1. These Rules may be cited as the Irrigation Association of Ayii Vavatsinias No. 2 ("Diploma" Water) Rules, 1952.

2. In these Rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Larnaca;

"Committee" means the Committee of the Irrigation Association;

"Irrigation Association" means the Irrigation Association of Ayii Vavatsinias No. 2 ("Diploma" Water);

"Law" means the Irrigation (Private Water) Association Law, 1949;

"List" means the list of the names and residences of the proprietors and of the extent of the interest of each proprietor in the water, as finally settled in accordance with the provisions of section 11 of the Law;

"works" means the irrigation works of the Irrigation Association.

3. The present Committee shall hold office for a period of three years beginning on the 30th December, 1951. The election of each subsequent Committee shall take place in the manner hereinafter provided every third year in the second week of the month of January and it shall hold office for a period of three years from the date of the expiration of the period of office of the previous Committee.
