## THE IRRIGATION DIVISIONS (VILLAGES) LAW.

CAP. 111.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, Cap. 111, the following rules made by the Committee of the Irrigation Division of Prodhromos, in the District of Limassol, are published in the Gazette.

## IRRIGATION DIVISION OF PRODHROMOS.

Gazette: 24.6.1932

These rules may be cited as the Irrigation Division of Prodhromos. (Amendment) Rules, 1952, and shall be read as one with the Irrigation Division of Prodhromos Rules, 1932 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Irrigation Division of Prodhromos Rules, 1932 and 1952.

2. Rule 5 of the principal Rules is hereby repealed and the following rule substituted therefor:-

"Every proprietor mentioned in the list shall pay a rate not exceeding ten shillings per annum, as may be prescribed by the Committee from time to time, for every pond used by him. The assessment will be based on a list of the proprietors of land showing the names of the proprietors who will be benefited by the Prodhromos Irrigation Works, and the number of ponds used by each, subject always to any changes of ownership which may occur from time to time and which will be notified to the Commissioner by the Irrigation Committee. Early in each year a copy of the said list signed by the Irrigation Committee shall be posted at a conspicuous place in the village, and a certified copy thereof shall be lodged with the Commissioner of Limassol."

## No. 370. THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAW, 1949.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Law, 1949, the following Rules made by the Committee of the Irrigation Association of Paleometokho ("Krashias" Water), in the District of Nicosia, are published in the Gazette.

IRRIGATION ASSOCIATION OF PALEOMETOKHO ("KRASHIAS" WATER). Rules.

- 1. These Rules may be cited as the Irrigation Association of Paleometokho ("Krashias" Water) Rules, 1952.
  - 2. In these Rules, unless the context otherwise requires-
    - "Commissioner" means the Commissioner of the District of Nicosia:
    - "Committee" means the Committee of the Irrigation Association;
    - "Irrigation Association" means the Irrigation Association of Paleometokho ("Krashias"
      - 'Law" means the Irrigation (Private Water) Association Law, 1949;
  - "List" means the list of the names and residences of the proprietors and of the extent of the interest of each proprietor in the water, as finally settled in accordance with the provisions of section 11 of the Law;
    - "works" means the irrigation works of the Irrigation Association; "water" means the water commonly known as "Krashias" water.
- 3. The present Committee shall hold office for a period of three years beginning on the 10th August, 1952. The election of each subsequent Committee shall take place in the manner hereinafter provided every third year in the first week of the month of August and it shall hold office for a period of three years from the date of the expiration of the period of office of the previous Committee.
- -(1) The Commissioner shall, not less than one month before the holding of the meeting as in rule 3 provided, cause a written notice thereof to be-
  - (a) published in a newspaper or newspapers; and
  - (b) posted in a conspicuous place in the town, village or quarter in which the water is
- (2) All expenses connected with the notices shall be paid for from the funds of the Irrigation Association.
