NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 1st September and the 30th October, 1952, flocks within the area of Pedayia, Nicosia District, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.

NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 124 in Supplement No. 3 to the *Gazette* No. 3613 of 19.3.1952, notice is hereby given that the following immovable property is required by the Governor for the undertaking of public utility mentioned therein :—

3. The Governor is willing to treat for the acquisition of the said property.
