The following rules made by the Village Health Commission of Paralimni, in the District of Famagusta, and approved by the Commissioner, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF
PARALIMNI UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Paralimni hereby make the following rules :—

1. These rules may be cited as the Village Health (Paralimni) (Amendment) Rules, 1952, and shall be read as one with the Village Health (Paralimni) Rules, 1938 (hereinafter referred to as “the principal Rules”), and the principal Rules and these rules may together be cited as the Village Health (Paralimni) Rules, 1938 and 1952.

2. Rules 20 and 46 of the principal Rules are hereby repealed and the following rules substituted therefor, respectively :—

“Rule 20. The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say :—

(a) For every bullock, camel, cow or ox	1	0
(b) For every goat or sheep	—	4½
(c) For every lamb or kid	—	4½
(d) For every swine	1	0

Rule 46. The following fees shall be paid by every person exposing for sale any fresh meat in the meat market, that is to say :—

(a) For every carcass of sheep or goat or part thereof ..	—	4½
(b) For every carcass of a young lamb or kid or part thereof	—	4½
(c) For every carcass of ox, camel, cow or bullock or .. part thereof	1	0
(d) For every carcass of swine	1	0

The following rules made by the Village Health Commission of Kapedhes, in the District of Nicosia, and approved by the Commissioner, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF THE
VILLAGE OF KAPEDHES UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Kapedhes hereby make the following rules :—

1. These rules may be cited as the Village Health (Kapedhes) Rules, 1952, and shall come into operation on their publication in the *Gazette*.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Karavostasi) Rules, 1938, published in the *Gazette* of the 4th March, 1938, shall—

(a) be deemed to be rules made by the Village Health Commission of Kapedhes and to be incorporated herein, and

(b) apply to the village of Kapedhes.

(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Karavostasi) Rules, 1938.

(3) Those rules of the Village Health (Karavostasi) Rules, 1938, mentioned in Part II of the Schedule hereto, shall not apply to the village of Kapedhes.
