THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAW, 1949.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Law, 1949, the following rules made by the Committee of the Irrigation Association of Kato Dhikomo ("Mana-tou-Nerou" Water), in the District of Kyrenia, are published in the *Gazette*.
IRRIGATION ASSOCIATION OF KATO DHIKOMO ("MANA-TOU-NEROU" WATER).
Rules.

1. These rules may be cited as the Irrigation Association of Kato Dhikomo ("Mana-tou-Nerou" Water) Rules, 1952, and shall be read as one with the Irrigation Association of Kato Dhikomo ("Mana-tou-Nerou" Water) Rules, 1950 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Association of Kato Dhikomo ("Mana-tou-Nerou" Water) Rules, 1950 and 1952.

2. Rule 7 of the principal Rules is hereby amended by the deletion therefrom of the words "twenty shillings" and the substitution therefor of the words "forty shillings".
