

**No. 492. THE MUNICIPAL CORPORATIONS LAW.**

ORDER IN COUNCIL No. 2574  
 MADE UNDER SECTION 124 (a) (i).

*Authority to the Council of the Municipal Corporation of Kyrenia to contract a loan.*

In exercise of the powers vested in me by section 124 (a) (i) of the Municipal Corporations Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows :—

1. The Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Kyrenia (hereinafter referred to as "the Municipal Corporation") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of five thousand pounds (£5,000) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say :—

- (a) the sum borrowed shall be repayable by the Municipal Corporation to the Lender in ten equal annual instalments (comprising sinking fund and interest), the first instalment being payable one year after the date of borrowing and all subsequent instalments being payable on the corresponding date of each year following until final repayment ;
- (b) the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual sum payable as aforesaid in the year to which such estimates relate ;
- (c) the sum borrowed shall be utilized by the Municipal Corporation for the repair and asphaltting of streets within the municipal area of Kyrenia.

2. For the purpose of securing the repayment of the sum under the loan, the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.

**No. 493. THE CONSULAR CONVENTIONS LAW, 1952.**

ORDER IN COUNCIL No. 2575  
 MADE UNDER SECTION 8 (1).

Whereas by section 8 (1) of the Consular Conventions Law, 1952, (hereinafter referred to as "the Law") it is enacted that the Governor may, by Order in Council, direct that sections 2, 4, 6 and 7 of the Law shall apply

to any foreign State specified in the Order, being a State with which a Consular Convention providing for matters for which provision is made by those sections has been concluded by Her Majesty ;

And whereas a Consular Convention (hereinafter referred to as "the Convention") between His late Majesty King George the Sixth in respect of the United Kingdom of Great Britain and Northern Ireland and His Majesty the King of Norway was signed at Oslo on the 22nd day of February, 1951, which provides for matters for which provision is made in the said sections 2, 4, 6 and 7, and which takes effect on the thirtieth day after the date of exchange of instruments of ratification ;

And whereas Her Majesty ratified the Convention :

Now, therefore, in exercise of the powers vested in me by section 8 (1) of the Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows :—

1. This Order may be cited as the Consular Conventions (Kingdom of Norway) Order in Council, 1952.
2. Sections 2, 4, 6 and 7 of the Law shall apply to the Kingdom of Norway.
3. This Order shall be deemed to have come into force on the 7th day of September, 1952.

**No. 494. THE CONSULAR CONVENTIONS LAW, 1952.**

ORDER IN COUNCIL No. 2576

MADE UNDER SECTION 8 (1).

Whereas by section 8 (1) of the Consular Conventions Law, 1952, (hereinafter referred to as "the Law") it is enacted that the Governor may, by Order in Council, direct that sections 4, 6 and 7 of the Law shall apply to any foreign State specified in the Order, being a State with which a Consular Convention providing for matters for which provision is made by those sections has been concluded by Her Majesty ;

And whereas a Consular Convention (hereinafter referred to as "the Convention") between His late Majesty King George the Sixth in respect of the United Kingdom of Great Britain and Northern Ireland and the President of the United States of America was signed at Washington on the 6th day of June, 1951, which provides for matters for which provision is made in the said sections 4, 6 and 7, and which takes effect on the thirtieth day after the date of exchange of instruments of ratification ;

And whereas Her Majesty ratified the Convention which was entered into force on the 7th day of September, 1952 :

Now, therefore, in exercise of the powers vested in me by section 8 (1) of the Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows :—

1. This Order may be cited as the Consular Conventions (United States of America) Order, 1952.
