THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of DefenceRegulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1951), I hereby order as follows:—

1. This Order may be cited as the Supplies and Services Lambs (Disposal and Slaughter) Control Order, 1952.

2.—(1) No person shall—

(a) purchase, sell or otherwise dispose of any lamb weighing less than twelve okes;

(b) slaughter any lamb weighing less than twelve okes;

- (c) have in his possession the carcass of a lamb weighing less than seven okes.
- (2) For the purpose of this paragraph the term "carcass" means the whole of the skinned carcass with the lungs, heart, liver and kidneys but without the other viscera.
- 3. I may appoint inspectors and the Commissioner of each District shall, if so required by me, appoint inspectors to ascertain whether the provisions of this Order have been or are being complied with and every inspector so appointed shall have power to enter at all times, at reasonable hours, upon any premises for the purpose of carrying out any inspection or search which may be reasonably required in order to ascertain whether the provisions of this Order have been or are being complied with.
- 4. Any person who acts in contravention of, or fails to comply with, any of the provisions of this Order, or who hinders or impedes any inspector in the exercise of any of the duties under this Order, is liable to the penalties prescribed in the Defence Regulations, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.
- 5. This Order shall come into operation on the 29th day of November, 1952.

6. The Supplies and Services (Control of Slaughter of Lambs) Order, 1947, is hereby cancelled without prejudice to anything done or left undone thereunder.
