In exercise of the powers vested in them by the Municipal Corporations Cap. 252. Law, and otherwise, the Council of the Municipal Corporation of Nicosia 11 of 1950 hereby make the following bye-laws:-

These bye-laws may be cited as the Nicosia (Amendment) Bye-laws, 1952, and shall be read as one with the Nicosia Municipal Bye-laws, 1938 to 1952 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Nicosia Municipal Bye-laws, 1938 to 1952.

- 2. Bye-law 121 of the principal Bye-laws is hereby amended by the insertion in paragraph (1) (b) thereof-
 - . (a) immediately after the word "premises" of the words "used as a Government Animal Quarantine Station or" and

THE FORESHORE PROTECTION LAW. No. 528. CAP. 92.

Notice under Section 3 (1).

In exercise of the powers vested in me by section 3 (1) of the Foreshore Protection Law, I do hereby absolutely prohibit-

(a) the removal of stones, shingle, gravel and sand or other substance from all parts of the foreshore lying within the Municipal limits of Larnaca, except that part which lies between the most northern point of plot 69 of Block J Scala, of the Government Survey Plan and the most southern point of the same plot:

Provided that stones, shingle, gravel and sand may be removed under the directions of the Collector of Customs, Larnaca, for use as ballast for sailing vessels from that part of the foreshore lying

between the Main Pier and the Quarantine Jetty;

- (b) the dumping of any rubble, rubbish, sweeping, litter, nightsoil or other refuse on any part of the foreshore within the municipal limits of Larnaca.
- 2. The notice published under Notification No. 158 in Supplement No. 3 to the *Gazette* of the 22nd April, 1948, is hereby cancelled without prejudice to anything done thereunder.
