NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 124 in Supplement No. 3 to the *Gazette* No. 3613 of 19.3.1952, notice is hereby given that the following immovable property is required by the Governor for the undertaking of public utility mentioned therein :—

2. Any person claiming to have any right or interest in the said property, who objects to the acquisition, is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said property.

4. A plan showing the property described above is available for inspection at my office in Limassol.

And whereas at a meeting of the proprietors of the Association held under Rule 18 of the Irrigation Association of Dhali ("Mikellis" Water) Rules, 1951 (hereinafter referred to as "the Rules") at the village of Dhali on the 30th November, 1952, it was decided by the requisite majority of the voters present thereat that the said Irrigation Association should be dissolved :
