# THE MUNICIPAL CORPORATIONS LAW. CAP. 252 AND LAW 11 OF 1950 AND 31 OF 1951.

## BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF FAMAGUSTA.

In exercise of the powers vested in them by the Municipal Corporations Cap. 252. 11 of 1950 Law, and otherwise, the Council of the Municipal Corporation of Fama-31 of 1951 gusta hereby make the following bye-laws :---

1. These bye-laws may be cited as the Famagusta Municipal (Amendment No. 2) Bye-laws, 1952, and shall be read as one with the Famagusta Municipal Bye-laws, 1940 to 1952 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the 24.10.1951 Famagusta Municipal Bye-laws, 1940 to (No. 2) 1952.

2. Bye-law 120 of the principal Bye-laws is hereby repealed and the following bye-law substituted therefor :---

"120. The inspector shall keep the slaughter-house open for the slaughtering of any animal on such days and at such hours as may from time to time be determined by the Mayor."

3. Bye-law 121 of the principal Bye-laws is hereby repealed and the following bye-law substituted therefor :---

" 121.—(1) Every person wishing to slaughter an animal shall submit it to the inspector for examination at least eighteen hours before it is to be slaughtered, and pending slaughter shall leave it in the lair near the slaughterhouse :

Provided that the provisions of this paragraph shall not apply to-

- (a) animals slaughtered in cases of emergency with the permission of the inspector ;
- (b) unweaned lambs or unweaned kids slaughtered between the 1st day of November and the 30th day of April, both days inclusive.

(2) The inspector may in his discretion refuse to allow any animal to be brought into the lair.

(3) No animal shall be taken away from the lair unless it is to be taken to the slaughter-house.

(4) No animals shall be allowed within the slaughter-house unless they are taken there for slaughter."

4. Paragraph (1) of bye-law 126 is hereby repealed and the following paragraph substituted therefor :---

"The inspector shall keep for use according to the nature of the case as many stamps as may be required, and shall stamp the appropriate stamp and in the appropriate ink and in such manner as to be clear and visible every carcass or part thereof which he passes as fit for human consumption. The design of the stamp, the colour of ink to be used with each, and the kind of animal for which each is intended, shall be fixed by the Mayor."

5. Bye-law 126 of the principal Bye-laws is hereby amended by the insertion therein immediately after paragraph (2) of the following paragraph :-

"(3) No meat or carcass of any animal slaughtered in the slaughterhouse shall bear any other stamp or seal except the stamp as provided in paragraph (1) of this bye-law and no person shall deform or discolour such stamp."

6. Bye-law 132 of the principal Bye-laws is hereby repealed and the following bye-law substituted therefor :---

" 132.-(1) (a) No person shall be engaged in the slaughter-house in slaughtering any animal or in the skinning, cleaning, or dressing of its carcass, unless he is the holder of a licence granted to him in that behalf by the Mayor.

(b) Every application for a licence shall be in writing and the applicant shall submit with his application two photographs of himself, one of which shall be affixed on his licence.

(c) Every licence shall expire on the 31st December following the date on which it was granted.

(d) Every application for the renewal of a licence shall be made at least one month before the expiration thereof.

(e) Every person to whom a licence is granted shall be issued with a number plate for which he shall pay a fee of three shillings to the Municipal Treasurer.

(2) A licence may be suspended or revoked at any time by the Çouncil if the holder—

- (a) refuses or fails to comply with any of the provisions of these byelaws;
- (b) hinders or obstructs the inspector or any other Municipal employee in the execution of his duties;
- (c) is convicted of a criminal offence;
- (d) is not in possession of a certificate of health;
- (e) causes wilful damage to the property of the Municipal Corporation.

(3) No person, other than a Municipal employee or officer in charge of the Police shall enter the slaughter-house unless he is in possession of a licence from the Mayor."

7. Bye-law 134 of the principal Bye-laws is hereby repealed and the following bye-law substituted therefor :---

"134.-(1) This Chapter shall not apply-

- (a) to animals slaughtered by Christians at Easter or by Mohammedans at the Qurban Bairam subject to the following qualifications—
  - (i) that such animals are not slaughtered for sale and no carcass or part thereof is exposed for sale or sold;
  - (ii) that the slaughtering is done on the owner's premises or such other place as may be appointed by public notification.

(b) to animals slaughtered in premises used as a Government Animal Quarantine Station :

Provided that no meat, carcass or edible offal of such animals shall be brought, sold or exposed for sale within the municipal limits unless such meat, carcass or edible offal—

- (i) bears visible and clear marks of the seal of such Quarantine Station and the appropriate stamp of the slaughter-house of the Municipal Corporation of Famagusta and a fee of two piastres in respect of every oke of such meat, carcass or edible offal has been paid to the inspector; and
- (ii) be conveyed by the Famagusta Municipal Meat Motor Lorries on payment of such transport fees as may be fixed from time to time by the Council.

(2) Save as is provided in paragraph (1) (a) of this bye-law, no person shall slaughter, skin, clean or dress, any animal outside the slaughter-house. The carcass of any animal slaughtered, skinned, cleaned or dressed outside the slaughter-house may be seized by any person in the service of the Council and disposed of as the Mayor may direct in writing."

"The above bye-laws have been approved by His Excellency the Governor. (M.P. 1961/49.)

THE STREETS AND BUILDINGS REGULATION LAW. CAP. 165 AND LAW 10 OF 1950.

# NOTICE UNDER SECTION 14 (1).

In exercise of the powers vested in them by section 14 (1) of the Streets and Buildings Regulation Law, the Municipal Corporation of Larnaca, as the appropriate authority of that Corporation under section 3 (2) (a) of the aforesaid Law, do hereby, with the approval of the Governor, define the area within the municipal limits of the said Corporation described in the Schedules A, B and C hereto as a zone within which buildings of a lesser value than three thousand pounds shall not be erected and the area described in Schedule D hereto as a zone within which buildings of a lesser value than one thousand five hundred pounds shall not be erected.

#### Schedule A.

All that area of land within the municipal area of Larnaca, lying between the main road from Larnaca to Famagusta and the sea and bounded on the north-east by plot No. 193 of the Government Survey Plan No. XLI/33 (on the village boundary of Voroklini) and on the south by the Larnaca bye-pass road, more particularly defined as the area coloured green on the Government Survey Plan Serial No. 1547.

#### SCHEDULE B.

All that area of land within the municipal area of Larnaca situated within 100 yards of the main road from Larnaca to Famagusta on its western side and bounded on the north by plot No. 27 of the Government Survey Plan No. XLI/41 (on the village boundary of Livadhia) and on the south by the Larnaca bye-pass road, more particularly defined as the area coloured brown on the Government Survey Plan Serial No. r547.
