**No. 110. THE LAND ACQUISITION LAW.**  
**CAP. 233 AND LAW 26 OF 1952.**

**NOTICE UNDER SECTION 6.**

With reference to the Notification published under No. 45 in Supplement No. 3 to the *Gazette* of 7th February, 1951, notice is hereby given that the following easement is required for the undertaking of public utility mentioned therein, that is to say, the establishment of a Military Cantonment in the villages of Pyla, Xylotymbou and Ormidhia in the District of Larnaca :—

The laying and maintaining of a pipe-line in, over or under the following lands, situated in the villages of Pergamos and Pyla in the District of Larnaca :

(a) In the village of Pergamos.

Plots Nos. 13, 304, 235, 221 and 215 of the Government Survey Plan No. XXXII.51, plots Nos. 26, 27, 28, 29/2, 30, 34, 35, 97.40, 97.39, 36, 37, 50, 51, 49, 48, 47, 82, 81/2, 81/3, 83, 95 and 84 of the Government Survey Plan No. XXXII.59.

(b) In the village of Pyla.

Plot No. 13 of the Government Survey Plan No. XXXII.59; plots Nos. 35, 36, 37, 49/1, 39, 43, 58, 59, 61/3 and 65 of the Government Survey Plan No. XLI.3; plots Nos. 257, 258, 255/1/3, 259, 260, 261, 262, 263 of the Government Survey Plan No. XLI.4; and plot No. 10 of the Government Survey Plan No. XLI.12.

The above-mentioned plots of land are shown on the Government Survey Plan Serial No. 1566 marked “Dhekelia Cantonment, Pergamos Water Supply Pipe Line” deposited with the Commissioner, Larnaca.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition of the said easement is required within ten days of the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said easement.

4. A plan showing the lands described above is available for inspection at my office at Larnaca.

5. The notice dated 7th January, 1953, published under Notification No. 35 in the *Gazette* No. 3669 of the 28th January, 1953, is hereby cancelled.

**THE STREETS AND BUILDINGS REGULATION LAW.**  
CAP. 165 AND LAW 10 OF 1950.

NOTICE UNDER SECTION 14 (1).

In exercise of the powers vested in me by section 14 (1) of the Streets and Buildings Regulation Law, I, the Commissioner of Larnaca, as the appropriate authority under section 3 (2) (b) of the aforesaid Law, do hereby define the area described in the Schedules hereto as a zone within which no residential, commercial or public building shall be erected of a lesser value than £3,000.

SCHEDULE " A ".

All that area of land in the village of Ormidhia in the District of Larnaca lying between the Xylytymbou Forest of the Minor State Forest (Xylophagou Group) and the road from Larnaca to Ormidhia village, bounded on the north and east by the said forest, on the south by the said road and on the west by the property of the Electricity Authority of Cyprus, more particularly defined as the area coloured red on the Government Survey Plan Serial No. 1577 a copy of which has been deposited at the Office of the Commissioner, Larnaca.

SCHEDULE " B ".

All that area of land in the village of Ormidhia in the District of Larnaca lying between the road from Larnaca to Ormidhia village and the sea, bounded on the north by the said road, on the east by a stream forming the eastern boundary of plot No. 148.4 of the Government Survey Plan No. XLI.22, on the south by the sea and on the west by the electric power station, except the Crown land marked in black, more particularly defined as the area coloured blue on the Government Survey Plan Serial No. 1577 a copy of which has been deposited at the Office of the Commissioner, Larnaca.
