# THE SHOP ASSISTANTS LAW. CAP. 159 AND LAW 8 OF 1952.

# ORDER IN COUNCIL No. 2607 MADE UNDER SECTION 19.

In exercise of the powers vested in me by section 19 of the Shop Assistants

Cap. 159.

Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

- 1. This Order may be cited as the Shop Assistants (Schedules Amendment) Order, 1953.
- 2. The provisions in the First and Second Schedules to the Shop Assistants Law are hereby deleted and the following provisions substituted therefor:—

#### "FIRST SCHEDULE.

## PURPOSES FOR WHICH A SHOP MAY REMAIN OPEN DURING CLOSING HOURS.

(Sections 4 and 5).

- 1. The sale by retail of intoxicating liquors.
- 2. Delivery of ice to hospitals and nursing institutions or, in case of sickness, to private persons.
- 3. The sale by retail of motor vehicle, cycle and aircraft supplies and accessories to travellers.
- 4. The servicing of motor vehicles and such mechanical repairs thereof as are immediately required for rendering such vehicles roadworthy.
- 5. The sale, in out-of-doors pavilions (commonly known as 'kiosks'), of sweets, chocolates, or other sugar confectionery or ice cream, fresh and dried fruit, newspapers and periodicals, razor blades, toilet soap, shaving cream or soap, tooth paste, picture postcards, photographic films and liquid refreshments other than intoxicating liquors as defined in the Sale of Intoxicating Liquors I aw (Cap. 152).
  - 6. The sale of medicines and of medical and surgical appliances.
- 7. The sale of refreshments for consumption on the premises or by hawkers.
  - 8. The sale of tobacco and smokers' requisites.
  - 9. The provision of meals in restaurants, hotels or khans.
- 10. The hire of bicycles and such repairs thereof as are immediately required for rendering them serviceable.
  - 11. Shoe-blacking.
- 12. The sale of any goods in any premises or place on such day or days and at such time or times as the Commissioner of the District may declare by notice in the *Gazette* on occasions on which groups of persons visit the Colony for a period of stay not exceeding one week or on the occasion of the calling of such tourist ships or aircraft at a port as the Commissioner of Labour may specify by notice in the *Gazette*.

- 13. The exhibition of cinematograph films.
- 14. The sale of any goods in any shops within an hotel access to which cannot be had otherwise than through the entrance of the hotel to persons residing therein.

### SECOND SCHEDULE.

## PURPOSES FOR WHICH A SHOP MAY REMAIN OPEN DURING A SUNDAY CLOSING.

(Section 6).

- 1. The sale by retail of intoxicating liquors.
- 2. Delivery of ice to householders and nursing institutions or, in case of sickness, to private persons.
- 3. The sale by retail of motor vehicles, cycle and aircraft supplies and accessories to travellers.
- 4. The servicing of motor vehicles and such mechanical repairs thereof as are immediately required for rendering such vehicles roadworthy.
- 5. The sale, in out-of-doors pavilions (commonly known as 'kiosks'), of sweets, chocolates, or other sugar confectionery or ice cream, fresh and dried fruit, newspapers and periodicals, razor blades, toilet soap, shaving cream or soap, tooth paste, picture postcards, photographic films and liquid refreshments other than intoxicating liquors as defined in the Sale of Intoxicating Liquors Law (Cap. 152).
  - 6. The sale of medicines and of medical and surgical appliances.
- 7. The sale of refreshments for consumption on the premises or by hawkers.
  - 8. The sale of tobacco and smokers' requisites.
  - q. The provision of meals in restaurants, hotels or khans.
- 10. The hire of bicycles and such repairs thereof as are immediately required for rendering them serviceable.
  - 11. Shoe-blacking.
- 12. The sale of any goods in any premises or place on such day or days and at such time or times as the Commissioner of the District may declare by notice in the *Gazette* on occasions on which groups of persons visit the Colony for a period of stay not exceeding one week or on the occasion of the calling of such tourist ships or aircraft at a port as the Commissioner of Labour may specify by notice in the *Gazette*.
- 13. The sale of meat, fish, cream, milk, bread, fruit and vegetables between 5 a.m. and noon.
- 14. The sale of any goods in any shops within an hotel access to which cannot be had otherwise than through the entrance of the hotel to persons residing therein.
- 15. The sale by auction of used or second-hand private effects in premises exclusively used for that purpose.
  - 16. Photography.
- 17. The sale of any goods in any premises or locality in any town, village or place during the holding of customary fairs.
  - 18. The exhibition of cinematograph films."
- 3. The Orders in Council set out in the Appendix hereto are hereby cancelled.

No. 144. THE MUNICIPAL CORPORATIONS LAW. CAP. 252 AND LAWS 11 OF 1950 AND 31 OF 1951.

Bye-laws made by the Council of the Municipal Corporation of Nicosia.

Cap. 252. 11 of 1950. 31 of 1951. In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Nicosia hereby make the following bye-laws:—

Gazettes: Supplement No. 3: 10.3.1939. 14.4.1949.

- 1. These bye-laws may be cited as the Municipal Corporation (Nicosia) Pensions and Gratuities (Amendment) Bye-laws, 1953, and shall be read as one with the Municipal Corporation (Nicosia) Pensions and Gratuities Bye-laws, 1939 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Nicosia) Pensions and Gratuities Bye-laws, 1939 to 1953.
- 2. Bye-law 13 of the principal Bye-laws is hereby amended by the deletion of sub-section (2) thereof and the substitution therefor of the following sub-section:—
  - "(2) The option referred to in sub-section (1) shall be exercisable, and if it has been exercised on or before the date of the publication of this bye-law may be revoked, not later than the day immediately preceding the date of the officer's retirement from a pensionable office."
- 3. The principal bye-laws are hereby amended by the addition immediately after bye-law 16 of the following bye-law:—
  - "16A. Where an officer, on retiring from the service of the Corporation on medical evidence under paragraph (d) of bye-law 16 has more than ten years' but less than twenty years' pensionable service, the same pension, if any, may be granted to him as might have been granted to him if his pensionable service had been twenty years."
